**Kang Chao.** A sweeping new interpretation of Chinese economic history emerges from this analysis of two millennia of economic developments in traditional China. Rejecting dynastic, positivist, and Marxian views, the author argues that since 200 B.C. China was a market economy consisting of countless small production units. With limited land for cultivation, freeholders and tenants were forced to adjust their economic choices and decisions in response to an increasing man-land ratio as population pressures mounted through the centuries. Although often labeled the culprit, it was not the unequal distribution of land but the increasing man-land ratio that led to China's impoverishment and technological stagnation. \$35.00

**Ronald Dore.** Union monopolies, cartels, tied dealerships—all the things that free-marketers denounce as “rigidities”—are to be found in Japan in abundance and in exaggerated form. Yet Japan adjusted far better to the international economic shocks of the 1970's than other countries. Why? The author finds the answer in an unseen and unsuspected flexibility in the manifold rigidities of the Japanese economy. This study focuses on the Japanese labor market, tracing its impact on Japanese trade policies and practices and presenting a detailed case study of the national textile industry. The author believes that the peculiar evolution of Japanese capitalism holds lessons for the West, notably Great Britain, concerning issues far greater than efficiency, quality control, and competitive success on the world market. \$32.50
