The project is to measure how hard middle class people work in different cultural settings by a comparative study of managerial-level people in cities of three Latin American countries, Chile, Venezuela and Argentine. Samples are being drawn from people working in the steel industry. Intensive interviews are the source of data.

462. JOHN TURNER. *Uncontrolled Urban Settlement in Peru*.

Included in the study will be a summary of the demographic and cultural aspects of urbanization, an evaluation of public housing and urban development policies, and a discussion of criteria and norms for popular housing and urban development as well as the analysis of the processes and characteristics of 'uncontrolled settlements' between 1945 and 1965.

486. ORRIS C. HERFINDAHL. *Economics of Natural Resource Surveys.*

This study examines the problem of how to use natural resource surveys and related techniques to facilitate and improve the planning of and the actual course of economic development. The study attempts to bridge the gap between two kinds of specialists—the specialist in applied natural science, who so often does the actual survey work, and the economist or planning official, who so often fails to make use of the valuable information generated by resource surveys. Research is being done in Latin America at the Instituto de Planificación Económica y Social, Santiago de Chile. Began, September 1965. In progress.

487. IGNACIO OLCOZ, Universidad Católica Andrés Bello. HENRY GOMEZ (O). RAYMOND F. MIKESSELL (C). *Business-Government Relations in Venezuela.*

Identification of areas of conflict between Venezuelan Government and foreign-owned petroleum companies and how these were settled over the years. Evaluation of economic effects of solutions and alternatives in terms of Venezuelan economic development. Measures of foreign-owned company (industry) contribution to Venezuelan economic development. Began, 1965. EDC, 1966./University of Oregon

488. LOWDON WINGO, JR. Instituto Latinoamericano de Planificación y Social, Santiago (C). *Determinants of Urban Infrastructure Investment in Developing Countries.*

This project is exploring the relationship between economic development policies on the one hand, and (1) changes in the demand for urban overhead services, and (2) the "supply response" on the other. The central phenomenon is development induced urbanization and the related internal migration processes. A major objective is to reformulate the infrastructure investment problem so that such investments can be viewed as calculable consequences of economic development decisions and policies. 489. NATHANIEL WOLLMAN. *Economics of Water Resources.*
