The authors look at long-term fluctuations, particularly cycles of prosperity and depression. Moreover, they give much-needed attention to the negative factors that affect an economy—such as conflicts, wars, and challenges to the economy—as well as to positive factors that encourage economic growth.

The central theme that unifies the text is a concern about the material well-being of the population. This focus makes economic theory seem less remote by demonstrating the impact of economic change on *people*, who are, after all, participants, not spectators, in an economy.

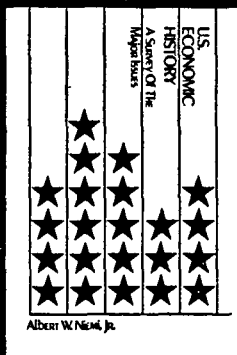

- **Combines modern and traditional approaches to economic history.**

In his *economic analysis*, Professor Brownlee uses clear English prose to explain the methods and results of quantitative research. Focus throughout the book is on growth, stability, and the distribution of income and wealth.

*Economic change* is explained chronologically in terms of politics, culture, and society.

- **Investigates the historical background of contemporary economic problems.**

Among the topics examined are the sources of domestic inflation, racial economic discrimination, the economic basis of U.S.-international relations, poverty, the crisis of the dollar, and the environmental crisis. Treatment of such problems is carefully integrated with the larger thematic concerns of the book.

- **Integrates social and economic history.**

The text explains economic change in terms of the patterns of social organization. Professor Brownlee weaves the "*new*" *social history*, which focuses on fundamental characteristics of the population (e.g., family structure; rates of natural increase, fertility, and mortality; race; urban-rural distribution), into the history of economic development.

Much attention is given to the economic participation in society of immigrants, women, and blacks.
