Grawemeyer Award Seeks Nominations for Ideas Improving World Order

The purpose of the Grawemeyer Award is to stimulate dissemination, analysis, and testing of outstanding proposals that can lead to more just and peaceful international relations. A cash award is given of \$150,000, payable in five annual installments of \$30,000.

Ideas are sought relative to foreign policy, the conduct of foreign relations, intercultural relations and communications, international law and organization, the rule of law and the role of force, international development, trade or investment. Originality, feasibility, and potential impact are major judging criteria. Individuals, government agencies, non-profit groups, international organizations, can be nominated. Chairs of political science departments, professional associations of political scientists or related disciplines, publishers and editors of books and journals in political science and international affairs are invited to submit nominations. Entries must be submitted in four copies and accompanied by entry form, nominator's letter, biographical sketch of nominee and agreement that the material will be placed in university archives. Non-English entries must be translated. Self-nomination is not allowed. Ideas or achievements must be presented or published within the last five years.

Profile in Courage Award Seeks Nominations

The nomination process for the third annual Profile in Courage Award is now open. The award will be presented at the Kennedy Library in Boston during a ceremony on May

29, 1992, the 75th anniversary of President John F. Kennedy's birthday.

The award is presented annually to the public official or officials at the federal, state or local level whose actions best demonstrate the kind of political courage that John F. Kennedy described in his 1957 Pulitzer Prize winning biography, *Profiles in Courage*.

The first Profile in Courage Award was presented to former Congressman Carl Elliott, Sr. from Alabama with the first award for leading the successful effort to enact the National Defense Education Act of 1958 which made higher education more accessible to all Americans. Congressman Elliott's political career was ended by the voters of Alabama when in 1966 he ran on a platform of economic opportunity for all Americans and was resoundingly defeated by the conservative forces in his own party.

Charles Longstreet Weltner, currently a Georgia Supreme Court Justice, was the 1991 recipient. As a Congressman in 1966, during his second term in the U.S. House of Representatives, Justice Weltner signed an oath of loyalty in support of the entire Democratic ticket in the general election. When Lester Maddox, an advocate of segregation, emerged as his party's nominee for Governor, Weltner placed principle above ambition and withdrew from his own race for re-election.

Ordinarily, the award will be made to living Americans who are elected officials, although in some cases, posthumous awards, awards to appointed officials, and awards to private citizens and citizens of other lands may be considered. The recipient receives a \$25,000 stipend and a sterling silver lantern designed by Edwin Schlossberg, Inc. and crafted by Tiffany & Company.

Carnegie Council Sponsors Student Contest

All undergraduate and graduate students enrolled in degree programs are eligible to enter the student essay contest, sponsored by the Carnegie Council on Ethics and International Affairs.

Essays should discuss the concrete application of ethics to particular problems in international affairs. Although submissions on any topic within the realm of ethics and international affairs are welcome, two areas are of special interest. The first is a focus on moral traditions and world change; for example, the sources of morality that have sparked change in places as diverse as Eastern Europe and Asia. The second is the relevance of normative standards, or the prescriptive principles of desirable behavior to which most nations can and do agree.

Essays should be approximately 25 pages, typed and double spaced, and preceded by a separate one to two paragraph essay summary. Essays should be clearly marked with the author's name, address, telephone number, and educational institution. Only entries submitted with a self-addressed, stamped envelope will be returned. The winning entry becomes the property of the Carnegie Council on Ethics and International Affairs.

First prize will be publication of the essay in the Spring 1992 edition of the Carnegie Council's annual

journal, *Ethics & International Affairs*. The contest winner will be notified by January 15, 1992.

William Ebenstein Political Theory Award is Established

The University of California at Santa Barbara has established the William Ebenstein Political Theory Award, in commemoration of the eightieth anniversary of his birth. The late Professor Ebenstein had a long and distinguished career as an author and professor of political science at the University of California at Santa Barbara, Princeton University, and the University of Wisconsin at Madison.

The award will be an annual stipend to the graduating senior who has written the best paper in political theory, as well as notification of this in the commencement program. Stein Rokkan Prize Offered for Comparative Social Science Research

The International Social Science Council, in conjunction with the Conjunto Universitario Candido Mendes (Rio de Janeiro) announces that the sixth Stein Rokkan Prize will be awarded in the autumn of 1992.

The prize is intended to reward a substantial and original contribution in comparative social science research by a scholar under 40 years of age on December 21, 1992. It can be either an unpublished manuscript of book length or a printed book or collected works published after December 31, 1989.

Four copies of manuscripts typed double spaced or of printed works

should be sent to the International Social Science Council before March 15, 1992, together with a formal letter of application with evidence of the candidate's age attached. Work submitted will be evaluated by the International Social Science Council with the assistance of appropriate referee or referees. The ISSC decision is final and not subject to appeal or revision.

The prize is US \$2,000. It may be divided between two or more applicants, should it be found difficult to adjudicate between equally valuable works submitted.

Northeastern Establishes O'Neill Chair in Public Life and Appoints Michael Dukakis as Visiting Distinguished Professor

The Department of Political Science at Northeastern University has established the Thomas P. O'Neill Chair in Public Life, which it intends to fill this academic year. The chair, endowed in honor of the former Speaker of the House and long-time representative from Massachusetts, is open both to prominent public figures and to outstanding scholars in any subfield of American politics, including foreign policy and public policy/administration. The department currently houses 22 faculty members, covers all areas of the discipline, and offers both M.A. and M.P.A. degrees and is pursuing the establishment of a Ph.D. program. The university is located at the center of Boston's thriving educational, political, and cultural life. The position has been advertised in the *APSA Personnel Newsletter*.

The department also is pleased to announce that Michael S. Dukakis, former Massachusetts governor and 1988 Democratic Party nominee for president, has joined the political science department at Northeastern as Visiting Distinguished Professor of Political Science for the 1991-92 academic year. Dukakis, who has taught previously at Harvard and the University of Hawaii, is teaching undergraduate courses on public policy and the American presidency, as well as graduate seminars in the M.P.A. program. Combined with his seminar (jointly taught with David Rochefort) on national health care policy, Dukakis presented a workshop and series of public forums on national health care policy. Research Project Needs Papers on Term Limitations

The National Civic League is seeking papers, articles, and speeches, on the issue of term limitations for elected officials at all levels of government, for use in a research project.

The League is particularly, but not exclusively, interested in any work that stresses the following topics: Executive v. legislative branch term limits; State legislature v. congressional term limits; and effects on term limits on minority and women candidacies.

The League's archives on term limitation and on other issues relating to government and active citizenship are open to League members and to other interested scholars, community activists, non-profit organizations, and journalists as appropriate. Any draft materials, or those not meant for distribution or quotation should be so marked. The League would seek permission in advance of any widespread distribution.

The National Civic League, a non-profit public policy advocacy organization, was founded in 1894 by Theodore Roosevelt and Louis Brandeis to promote community self-governance and to reform the structures of local government. Today, the League advocates the active involvement of informed and motivated citizens in the governance of their communities. The National Civic League has not taken a position on the issue of term limitation for elected officials.

Institute for the Study of Diplomacy Creates New Center to Revise and Distribute Pew Case Studies

Hans Binnendijk, director of the Institute for the Study of Diplomacy

(ISD) at Georgetown University, announced today the Institute's plans to create a new center to revise and distribute the Pew Case Studies in International Negotiation. With support from a three-year grant of \$255,000 from The Pew Charitable Trusts, the Institute will conduct a systematic review of 150 case studies designed for instructional use in professional, graduate, and undergraduate courses in international affairs. The Pew cases, prepared over three years by scholars at seven participating institutions, have been tested in the classroom for three additional years at hundreds of colleges and universities throughout the United States.

On September 1, the University of Pittsburgh Graduate School of Public and International Affairs (GSPIA) will formally transfer the clearinghouse functions it has carried out since September 1988 to ISD. During a transition period, as the case studies are undergoing review and revision, ISD will continue to distribute them in their existing form to avoid disrupting their availability for use in the classroom. Over the next three years, the Institute will reissue each case after it has been reviewed and any necessary changes made.

Modeled after the widely used Harvard Business School cases, the Pew case studies are drawn from actual international negotiations dealing with politics, economics, strategy, trade and security and are intended to stimulate extended classroom interaction. The seven higher educational institutions responsible for preparing the cases—Columbia, Georgetown, Harvard, the International Peace Academy, Johns Hopkins, Pittsburgh and the University of Southern California—shared in the grant of \$2,500,000 with which The Pew Charitable Trusts launched the program in 1985.

National Issues Convention Will Be On PBS

On January 17, 18, and 19, 1992, at the University of Texas, Austin, Texas, six hundred American voters, representing the national electorate, will gather to discuss the issues with

Democratic and Republican potential presidential candidates and other party leaders. Their conclusions will shape the debate for the 1992 presidential election campaign.

Over the three-day period, PBS will broadcast live coverage, highlights, background pieces and commentary from this unprecedented experiment in participatory democracy.

New Institute Will Focus on Interdisciplinary Research in European Public Policy

The University of Warwick, England, has established a European Public Policy Institute based in the department of politics and international studies. The institute will provide a focus for collaborative interdisciplinary research related to European public policy. Jeremy Richardson, currently head of the department of politics at the University of Strathclyde, is joining the department as professor of European integration and head of the new institute.

Freedom Forum Announces New Grants

The Freedom Forum (formerly Gannett Foundation) has given a grant of \$100,000 to the University of California School of Journalism to support the "Women, Men and Media" project, a watchdog group monitoring gender-related issues in the media. Comparative Representation and Electoral Systems Research Committee Invites New Members

The Comparative Representation and Electoral Systems Research Committee (ESRC) of the International Political Science Association (IPSA) is an organization of over 200 individuals from 29 countries who seek to facilitate research into the comparative forms and effects of representation and electoral systems. The resulting network of international scholars includes individuals interested in national, cross-national, and sub-national aspects of representation and electoral systems.

The committee organizes panel opportunities for scholars to present and discuss papers at the meetings of the IPSA.

Since 1986, the Research Committee has published and distributed to its membership a bilingual *International Newsletter*. Each issue features a section, "Scholarly Extensions," which provides an outlet for scholars of representation and electoral systems to present interesting data, summaries of larger research efforts, theoretical statements, or critiques of other works. The newsletter also offers members discount arrangements for selected international journals and scholarly books in the field.

Periodically, the Research Committee also distributes the ESRC *International Directory and Research Register* to its members. The recently issued 1991-92 edition contains detailed membership information and listings of current research interests for over 200 scholars from 29 countries.

In January 1992, the Electoral Systems Research Committee will release its newest publication, the Revised and Expanded 1992 Third Edition of the *International Bibliography on Electoral Systems* by Richard S. Katz of The Johns Hopkins University, USA. This 90-page compilation identifies in some 35 distinct categories over 1800 major works dealing with the forms and effects of representation and electoral systems, including national, cross-national, and sub-national

studies. This bibliographical reference will be available January 1992 at a postage-paid cost of \$8 U.S. or (£6 sterling) for members, or \$15 (or £11) for non-members. Copies will be mailed immediately upon publication in January.

The European Policy Research Unit in the Department of Government at the University of Manchester, United Kingdom, was

originally established in 1989. In the last year it has expanded its program of research and seminars. Members of the unit are contracted to major research initiatives recently funded by the UK Economic and Social Research Council.

Under the Council's Single Market Initiative, Simon Bulmer is to conduct a study of the rule-making process in the community, while Jill Lovecy, Margaret Brazier, and Michael Moran are to carry out a comparative study of the impact of the single market on the organization of professions in the United Kingdom and France. In the Council's East-West initiative, Michael Waller is to coordinate a team studying the process of party formation in reconstructing political systems of Eastern Europe. New Service Compiles Local Reapportionment News

A new service designed to aid decision makers of reapportionment and redistricting issues is now available. Called the *Telebase Reapport*, it uses computerized databases to track reapportionment activities at the state and congressional levels throughout the country.

Developed by Telebase Systems, Inc. of Bryn Mawr, Pennsylvania, the *Telebase Reapport* provides the subscriber with a weekly report, consisting of up to 50 recent newspaper articles. Telebase uses computers to search 60 local newspapers from Anchorage to Miami and retrieves the full text of relevant articles—just as they appeared in print. Interviews with Federal Judges Compiled for Directory

In 1988, the Federal Judicial History Office began collecting information on existing oral history interviews related to the federal courts. The survey included both federal court history programs and private oral history collections. To date, more than 900 such interviews have been located; persons interviewed comprise court staff, litigants, associates of important figures, members of the bar, and federal judges themselves.

The information gathered about these recorded interviews is published in a directory by the Federal Judicial Center as of fall 1991.
