## Information for prospective contributors

The Editors are pleased to receive manuscripts for publication in *Transnational Environmental Law*. For detailed submission instructions, see [www.journals.cambridge.org/tel/ifa](http://www.journals.cambridge.org/tel/ifa).

All manuscripts must entail original, previously unpublished work, and should not be under consideration for publication elsewhere. The Editors will also consider revised versions of previously released working papers, provided that such publication is clearly acknowledged upon submission of the paper for consideration to *TEL*. Authors wanting to submit a mostly identical version of publicly available working papers for review are advised to contact the Editors prior to submission.

The length of manuscripts should normally range between 8,000 and 11,000 words (including footnotes) for full-length articles; 3,000–6,000 words for commentaries and case notes; and 1,000–2,000 words for book reviews. Exceptionally, shorter or longer works may be considered at the Editors' discretion.
