David A. Messenger is an Associate Professor of history at the University of Wyoming. He is the author of *L'Espagne Republicaine: French Policy and Spanish Republicanism in Liberated France* (Sussex Academic Press, 2008) and is currently preparing a study of ex-Nazis in Spain after the Second World War. His work has been published in *French History*, *International History Review*, *Intelligence and National Security* and other journals.

Zsolt Nagy is a PhD candidate in Modern European History at the University of North Carolina at Chapel Hill. He is currently working in his dissertation on interwar East-Central European cultural diplomacy, with special emphasis on Hungary. An earlier version of this article recently won the Association of Slavic, East European, and Eurasian Studies (formerly AAASS) Graduate Student Essay Prize as well as the Graduate Student Essay Prize from the Southern Conference on Slavic Studies.

Kiran Klaus Patel held the joint chair in EU history and transatlantic relations at the European University Institute in Florence, Italy, until August 2011, and is now professor of European and global history at Maastricht University in the Netherlands. His most recent publications include: *The United States and Germany during the 20th Century: Competition and Convergence* (Cambridge University Press, 2010, ed. with Christof Mauch); *Europeanization in the Twentieth Century: Historical Approaches* (Palgrave, 2010, ed. with Martin Conway); *Europäisierung wider Willen: Die Bundesrepublik Deutschland in der Agrarintegration der EWG, 1955–1973* (Oldenbourg Verlag, 2009); *Fertile Ground for Europe? The History of European Integration and the Common Agricultural Policy since 1945* (Nomos, 2009, ed.).

Filipe Ribeiro de Meneses is the author of, among other works, *Portugal 1914–1926: From the First World War to Military Dictatorship* (University of Bristol, 2004), *Salazar: A Political Biography* (Enigma Books, 2009), and *Afonso Costa: Portugal* (Haus, 2010). He is currently investigating Portugal's ties with South Africa and Rhodesia in the 1960s and 70s.

Johan Schot is a professor of the social history of technology at the Technical University, Eindhoven. He chairs the Tensions of Europe Collaborative Research

Program and Network. His recent publications include *Technology and the Making of the Netherlands: The Age of Contested Modernization, 1890–1970* (MIT Press, 2010), and *Transitions to Sustainable Development: New Directions in the Study of Long Term Transformative Change* (Routledge, 2010). In his current research he focuses on the role of (technical) expert networks, their technocratic visions in the policy-making of international organisations and their influence on the process of European integration and fragmentation.

Laurent Warloutzet is a lecturer at the University of Artois (Arras, France) and at Sciences Po in Paris, and specialises in the history of European integration, with a particular interest in institutional and economic issues. To date he has published three books (two co-edited volumes and a textbook; a fourth, based on his Ph.D. thesis, is in press), a dozen or so papers in French and five in English (two journal articles, two contributions to an edited volume, and a European University Institute working paper on the history of European competition policy).

## NOTES FOR CONTRIBUTORS

*Contemporary European History* covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

### Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at [ceh@sheffield.ac.uk](mailto:ceh@sheffield.ac.uk), or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, [weiner@stanford.edu](mailto:weiner@stanford.edu)

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

### Prospective authors should refer to the full set of Instruction for Contributors by following the link at <http://www.journals.cambridge.org/ceh>

- Contributors of accepted papers should send a final version via email. This should include
1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
  2. a 100-word summary of the article in English, French or German
  3. a short title for use as a running page-head
  4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
  5. a short description of work in progress and previously published work
