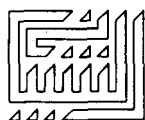

Legal Considerations on the International Status of Jerusalem - Antonio Cassese - examines the complex issues of sovereignty over West and East Jerusalem and the legal responsibility of the United Nations in this respect.

Sharon vs Time: The Criminal Responsibility under International Law for Civilian Massacres - Linda Malone - analyses the criminal responsibility of Sharon for the Sabra and Shatilla civilian massacres under both U.S. and international law.

Law Reports - are mainly dedicated to the human rights question of *deportation* of Palestinian civilians. From Israeli records there are three leading Supreme Court judgments on deportation and one judgment on family reunion. These are followed by a compilation of Israel's laws of deportation as enacted by Israel in pre- and post- 1967 occupation. The late Palestinian Attorney, Aziz Shehadeh, analyses the issue of deportation in the light of the relevant Mandate and Jordanian laws that existed in the West Bank before it was occupied by Israel in 1967. A study on the policy of deportation as pursued by the Israeli authorities in the Occupied Territories is also reproduced.

The Reports cover the judgment of the Sudanese Special Security Court in the *Falashas* case.

Special Report - includes the first part of the *Arab Boycott Regulations*; this is probably the first up-to-date, English version of these Regulations.

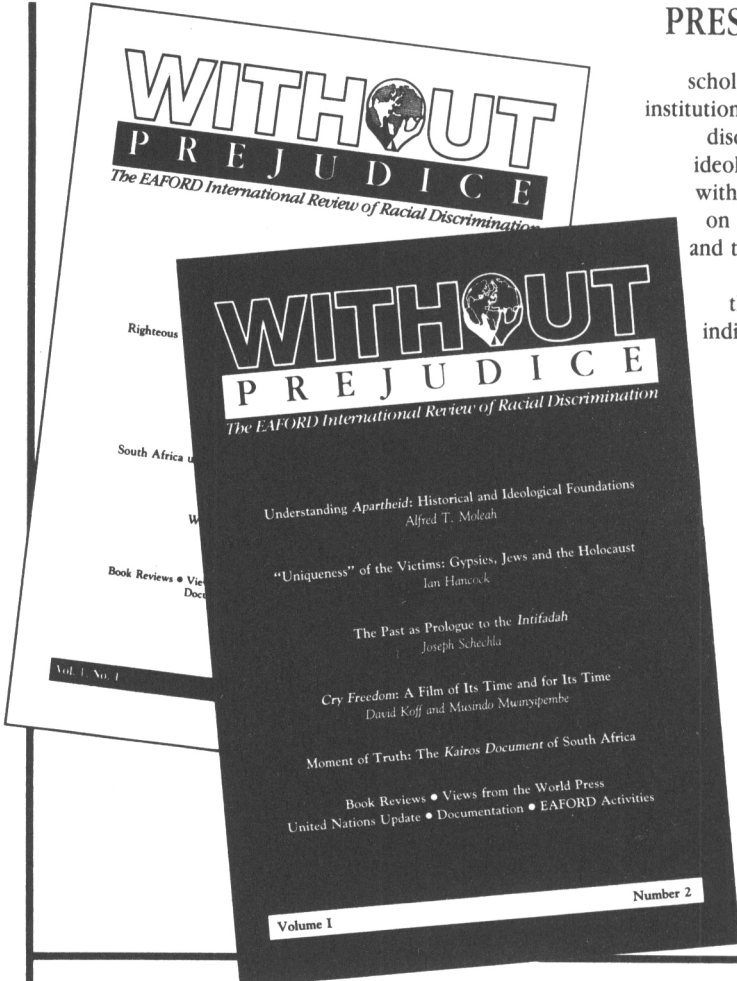
