The English–German part (German–English was published in 1971) completes the fundamentally new edition of the "Taschenwörterbuch der Rechts- und Geschäftssprache", last published in 1947.

The increasing legal involvements of the Federal Republic of Germany and the English-speaking countries made this new edition an urgent necessity. The vocabulary of this edition represents a completely new compilation and while restricted to the technical terminology of law, takes into account all related disciplines. Thus, it incorporates relevant terms drawn from the military, tax, customs, insurance, traffic and communications fields, as well as from business and finance, money and banking, and the stock exchange.

Differences in the development of the law in Germany and the Anglo-American countries have led to differences in legal concepts which create gaps in understanding. Though the concepts of justice are similar, the methods and character of legal inquiry differ. Furthermore, corresponding legal concepts of different legal orders are not coextensive, nor do they have the same legal consequences. Nevertheless, it is possible to collate the legal terminologies of these two different legal systems. For this purpose the author has endeavored, in cases where there is no corresponding legal concept or institution, to provide terms which are as nearly equivalent as possible. Where the same or similar concepts or institutions do not exist, corresponding have been employed. In many instances, the difference between the German and the Anglo-American systems has been taken into account through new translations which offer the English-speaking and the German-speaking users of this dictionary the nearest possible equivalents. Concepts or institutions existing only in Great Britain or in the United States are indicated by (GB) and (USA), respectively.

Because of the copious nature of the material drawn from the study of relevant literature and practical experience, the English–German part is much more comprehensive than the first volume of this work, separately published in 1971. Each entry has been selected on the basis of its importance for the user. In addition to purely technical terminology, certain general concepts have been included. It has likewise seemed advisable to include numerous combinations of words as a guide for various formation of compound words. Furthermore, numerous examples have been given for the purpose of enabling the user to avoid incorrect usage or construction.

The first edition of *International Governmental Organizations* was published in 1956, the outcome of a project which Amos J. Peaslee had been considering since the war years and had embarked upon together with "Constitutions of Nations" in 1946. A second edition, containing entries for 35 new and additional organizations and revisions for numerous others, was published in 1961 and covered 135 organizations.

In this edition, revised for a third time, the organization of the volumes has been changed. The number of international organizations has become so large that it seems more practical to abandon the alphabetical system in favor of some sort of subject division. Thus the different volumes may be acquired separately and each one may form a unit. Since they can be prepared separately, they may also be more up-to-date. Consequently the 3rd edition is made up of five Parts, which will be of varying lengths in accordance with the number of organizations falling within each category.

The subject division corresponds approximately to the area covered by the United Nations and its specialized agencies which form since the Second World War, the central complex of international organization. Their membership is virtually universal and their functions cover so wide a field that almost all other international organizations are in some way affected by their activities or contribute to them and thus stand in some sort of working relationship to one or more of the United Nations bodies.

The organizations included are multilateral and governmental. Part Two covers general and regional organizations concerned with agriculture, commodities, fisheries, food and plants. It contains 51 entries. Twenty eight organizations are covered for the first time, and for thirteen entries already included in the second edition the basic documents have been amended or revised. All the summaries have been revised and the list of members brought up to date.

The Food and Agriculture Organization, a specialized agency of the United Nations, is the general organization covering all these fields and its Constitution appears in this volume. Almost all the organizations here contained have relations with FAO, a number of them have been set up under its auspices, act as regional organizations for FAO, or are in some other manner directly a part of the FAO framework.

The subsequent volumes will deal with education, culture and copyright (Part III); science and health (Part IV); communications and transportation (Part V).

There will be found at the end of Part II (and it will be reprinted in all the remaining volumes, being brought up to date as and if necessary) an index to all the volumes. Also at the end of each Part there will be found tables showing the membership of the organizations.
