In this study, the author analyzes the myths surrounding Chamberlain's role in major controversies and reassesses his political importance.

British Military Policy Between the Two World Wars

BRIAN BOND. In the 1920's the British Army was starved of new equipment and relegated to the role of imperial policing. With the rise of Hitler its possible role in Europe was endlessly debated but it was not until 1939 that a definite commitment was accepted. This study examines the reasons for the indecision and argues that uncertainty over its role was more important than military conservatism in accounting for the Army's unpreparedness in 1939.

JOHN D. FAIR. British interparty conferences were an informal procedure adopted on at least a dozen occasions between 1867 and 1921 to encourage conciliation between political parties. Making use of original letters and documents, Professor Fair presents a clear and balanced account of the value and limitations of conciliation as a method for achieving a legislative settlement, a greater national unity, or perhaps even peace.
