A Brazilian Plantation System, 1820-1920

Warren Dean. Nowhere were the economic and social consequences of Brazil's dominance in the world coffee market more intensely contested than in the agricultural center of Rio Claro: land expropriation and the founding of huge estates, slave labor and the abolition of slavery, European immigration, economic diversification, the steady transfer of labor and capital to richer inland areas. This study concerns the successive waves of people who made up the plantation's labor force, from African-born slaves to free laborers and immigrants. It illuminates the basic character of the system—profitability, efficiency, labor relations, local and national influence—and has direct implications for other plantation societies throughout the world. \$11.50

Wayne A. Cornelius. The world-wide population shift from rural to urban areas in the developing nation is especially significant in Latin America, which has surpassed all other Third World regions in urban population growth. Based on extensive research of political attitudes and behavior in six low-income communities, this is the first detailed study of political learning among rural-to-urban migrants in Mexico. Broadly comparative and interdisciplinary in scope, this work breaks new ground in the study of Mexico's rapid urbanization and offers a creative model for future studies of the local community as an arena for social and political action. \$12.50
