Essays in Nigerian Foreign Policy

Olajide Aluko

Nigerian foreign policy has moved from the cautious role adopted in the early 1960s to an active and dynamic one in the period since the civil war. In this book Professor Aluko examines why and how this has happened. He subjects both the policy and the Nigerian Foreign Service to close scrutiny, looking at the policy towards West African neighbours, the policy towards the rest of Africa and policy towards extra-African powers, as well as the impact of civil war. Professor Aluko's approach is neither historical nor theoretical, but combines the analytical and empirical together with helpful models and facts, thus illuminating our understanding of the intricacies of Nigerian foreign policy, especially the process of decision-making.

Child-Spacing In Tropical Africa: Tradition And Change

This book focuses both on evaluating the demographic consequences of current child-spacing patterns and trends, and on the social, economic and cultural environment that underpins traditional practices and changes in them, providing an integrated analysis of the first large body of demographic data available from tropical Africa. As more data become available from other regions, studies such as this will prove to be an integral part of research on changing patterns of fertility, and this book should provide a model for future analyses.

The study of the matrilineal peoples of the Luapula region of Zambia challenges one of the most entrenched assumptions in modern anthropology. Universal male dominance, concludes Karla Poewe, is an ethnological illusion — rather, we should acknowledge the existence of several patterns of male-female interaction or gender systems, determined by the particular kinship ideology governing the society.

Cultural Regions of East Africa

John D. Kesby

Much of the detailed literature on East African peoples has dealt with small areas or with individual ethnic groups. This study is a broader survey, treating East Africa as a whole and answering a series of general questions about its different groups — why did they become established where they did, where did they come from, and how do their cultural differences and similarities coincide or contrast with the physical and vegetational differences between the regions of East Africa?
