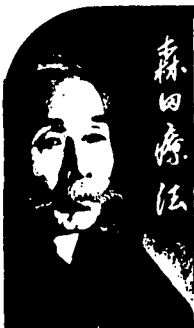

Robert Hart's forty-five year administration as Inspector General of the Chinese Maritime Customs represented a constructive side of the unequal treaty system and Victorian Britain's informal empire in East Asia.

Hart built up an international staff of thousands, facilitated foreign trade, gave the late-Ch'ing court its principal new revenues, and fostered China's modernity in administration, schools, naval development, and postal service. Behind the scenes he was also a diplomat who resolved the Sino-French war, changed Macao's status, settled boundaries with Burma and India, and helped to mitigate the disasters of imperialism.

These deeply personal letters bring to life a vanished era. And provide a primary source for students of modern China and the era of foreign privilege there.
