Ownership and Publication of *Mathematika*

Mathematika was founded in the early 1950s by Harold Davenport and is owned by University College London. Since 2010, the journal has been published on behalf of its owner by the London Mathematical Society (LMS). The LMS is the major British learned Society for mathematics and publishes eleven other journals, five of which are in collaboration with other learned societies. Cambridge University Press prints and distributes *Mathematika* under agreement with the London Mathematical Society.

Prior to 2010, the journal had not been published on-line, but since 2010 all articles, including the full archive dating back to 1954, are available electronically via Cambridge Journals Online.

Aims and Scope

Mathematika publishes both pure and applied mathematical articles of the highest quality. The traditional emphasis has been towards the purer side of mathematics but applied mathematics and articles addressing both aspects are equally welcome.

Submission of Manuscripts

Authors wishing to submit a paper for publication should follow the guidelines available via the webpage <http://www.lms.ac.uk/content/publications>.

Authors will be asked to assign copyright to University College London prior to publication.

No paper should have been published or be under consideration for publication elsewhere. Nor may the paper be submitted elsewhere while it remains under consideration by *Mathematika*.

A URL giving free access to the final published article will be provided free of charge. Offprints can be ordered on the form which will accompany the page proofs.
