NOTES ON CONTRIBUTORS

Richard B. Brandt is Professor of Philosophy at the University of Michigan. Among his books are *Hopi Ethics: A Theoretical Analysis* (1954), *Ethical Theory* (1959), and *A theory of the Good and the Right* (1979).

Claudia Card is Associate Professor of Philosophy and Courtesy Associate Professor of Women's Studies at the University of Wisconsin-Madison. She teaches and publishes in the areas of ethics, philosophy of feminism, sexual politics and lesbian culture.

E. Jennifer Ashworth is Professor of Philosophy at the University of Waterloo. Articles of hers have appeared in various journals, including *Archiv für Geschichte der Philosophie*, the *Notre Dame Journal of Formal Logic*, *Dialogue*, *The American Philosophical Quarterly* and *The Journal of the History of Philosophy*. She is the author of *Language and Logic in the Post-Medieval Period*.

Michael Philips is Associate Professor of Philosophy at Portland State University and is currently Visiting Associate Professor at the University of Miami. He has recently published papers in ethics and applied ethics in *The Australian Journal of Philosophy*, *The Journal of Value Inquiry*, *The Journal of Business Ethics* and *The Law and Society Review*.

Thomas J. McKay is Associate Professor of Philosophy at Syracuse University. He has published articles on logic and philosophy of language in various journals including *Philosophical Studies*, *Journal of Philosophical Logic* and *Noûs*.

John Pollock is Professor of Philosophy at the University of Arizona and Editor-in-Chief of *Philosophical Studies*. He is author of *Knowledge and Justification*, *Subjunctive Reasoning*, *Language and Thought*, and *The Foundations of Philosophical Semantics*, together with numerous journal articles in epistemology, the philosophy of language, and the philosophy of logic.

Peter Smith is Lecturer in the Department of Philosophy at the University College of Wales, Aberystwyth. He has published recently in *Analysis*, *Mind*, *Philosophical Investigations* and elsewhere, on topics in the philosophy of mind and philosophy of logic. His paper 'On Identifying the Mental with the Physical' appeared in the *Canadian Journal of Philosophy* 13 (1983).

Thomas Vinci is Associate Professor of Philosophy at Dalhousie University. He has published papers in various journals on topics in epistemology, the philosophy of science and the history of philosophy. Of special relevance to the contribution in this journal are 'Gettier Examples, Probability and Inference to the Best Explanation,' *Philosophia* 12 (1982), and 'Sellars and the Adverbial Theory of Sensation,' *Canadian Journal of Philosophy* 11 (1981).

Petra von Morstein is Professor of Philosophy at the University of Calgary. Her major philosophical interests include philosophy of mind, aesthetics, history of philosophy from the 17th to the 20th century and analytic and European philosophical methods. She has published most recently in *Mind*, *The British Journal of Aesthetics*, *The Journal of Aesthetics and Art Criticism*, *Grazer Philosophische Studien*, and *Conceptus*.

J.F.M. Hunter is Professor of Philosophy at University of Toronto. He has published papers on ethics, political philosophy, philosophical psychology and the later Wittgenstein, and also *Essays after Wittgenstein*, *Intending*, and *Thinking about Sex and Love*. A volume of his papers interpreting the *Philosophical Investigations* will be published by Edinburgh University Press.
