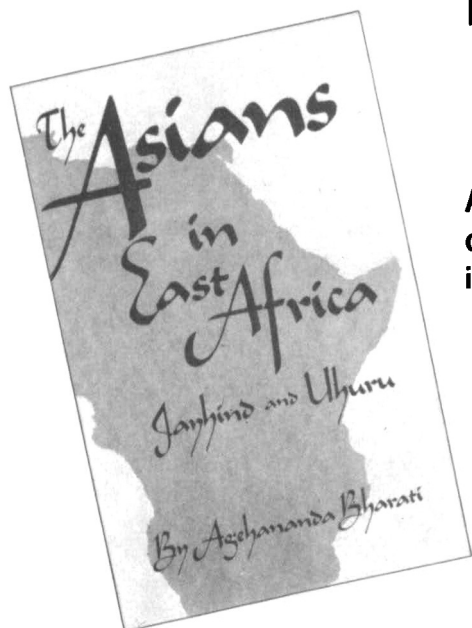

This is the first anthropological study of the Indians in East Africa—a harrassed, large, and important community of expatriates. The life-style, kinship patterns, and the social structure of the 360,000 Indians who live in Kenya, Uganda, and Tanzania are investigated with uncommon insight.

Dominant themes in this study are: the political, religious, and ideological image of the minority; their interpersonal relations; the male-female problems of a puritanical society in an expatriate setting; racial prejudices and race relations of the Asians, the Africans, and the whites; the emerging modernization. Psychological stress and defense mechanisms in a hostile social and political environment are described.

The field work and preparation of this study were supported by the Crosscultural and African Sections of the Maxwell School of Public Affairs and Citizenship at Syracuse University, where Professor Bharati is chairman of the Department of Anthropology. \$14.00

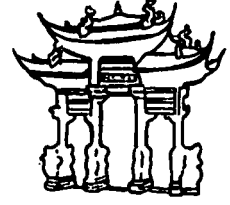

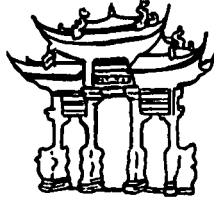

This text for undergraduate general education or introductory courses in Chinese civilization includes both a history of the span of Chinese civilization, traditional and modern, and a separate set of essays examining China from the viewpoint of most of the relevant disciplines. The first half of the book consists of a short cultural history that underscores developments of general and enduring significance in the life of the civilization. The second half of the book is composed of essays on patterns or configurations that distinguish Chinese society from others, or that characterize one particular facet of the civilization. The subjects include archeology, pre-modern economics, language, anthropology, political institutions, art, geography, literature, modern economic development, and the social functions of religion. These chapters describe current understanding of the subjects by established scholars, without involving the student in excessively complicated or technical data.

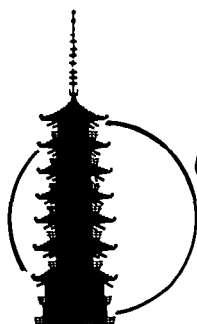

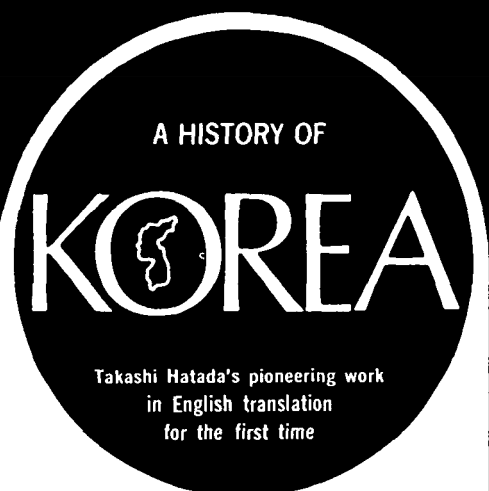

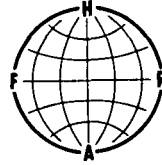

DEWEY SPEAKS— China Listens, 1921

PEKING (UPH)—John Dewey, eminent American philosopher and educator, left China today after twenty-six months of lecturing and teaching throughout the country. Dewey has delivered over 100 lectures to educators and government officials. His most recent series was presented at Peking National University and included 32 speeches on the topics: "Social and Political Philosophy," and "Philosophy of Education."



Since that time, John Dewey has been hailed as the single most influential foreigner on Chinese thought in the period between the Manchus and the Maoists. His many speeches, delivered in English, were translated and widely distributed in Chinese. However, they have been lost to the Western world until now.

LECTURES IN CHINA, 1919-1920 is the first collection of Dewey's final 32 speeches available in any language. Retranslated by two of the foremost Dewey scholars, these lectures fill "a regrettable lacuna in Dewey scholarship."
