CHARLES M. BARRESI, Associate Professor of Sociology at the University of Akron, is the author of several articles on urban renewal. He is currently involved in research dealing with the effects of urban renewal relocation on single persons and the study of changes in work role conceptions of the elderly.

ROGER W. BENJAMIN, Assistant Professor of Political Science at the University of Minnesota, co-authored "The Minnesota Public Defender System and the Criminal Law Process," which appeared in this Review in November 1969. Interested in political development and political behavior as well as the behavior and attitudes of participants in the criminal justice process. Professor Benjamin has just returned from a year's leave at the Institute for Social Research, Tokyo University.

ROLAND J. CHILTON is Associate Professor of Sociology at the University of Massachusetts in Amherst. A former member of the staff of the President's Commission on Law Enforcement and Administration of Justice, Professor Chilton is currently engaged in a statewide survey of Florida's Criminal Justice System.

HENRY ROBERT GLICK is Assistant Professor of Government at Florida State University. His major fields of interest are judicial behavior, state politics, and interest groups. He is author of a forthcoming research monograph on judicial role perceptions and behavior entitled Supreme Courts in State Politics.

STANLEY E. GRUPP, Professor of Sociology at the Illinois State University, is the author of numerous articles on criminology, his main field of interest. He has edited a book on criminology, The Positive School of Criminology, and is currently publishing several articles dealing with criminology and marihuana use.

PHILIP J. HANNON, whose article on "The Leadership Problem in the Legal Services" appeared in the November 1969 issue of Law & Society Review, is currently Assistant Professor of Government at Skidmore College. Professor Hannon is in the process of writing a book about politics and the poverty lawyer.

JOHN H. LINDQUIST is currently Associate Professor of Sociology at Trinity University, San Antonio. The co-editor of a book of readings on American Public Opinion, he is now involved in a cross-cultural study of women in national politics and elderly men in urban society.

DIETRICH RUESCHEMEYER, Associate Professor of Sociology at Brown University, was a Visiting Professor of Sociology at the Hebrew University in Jerusalem (1969). He is presently preparing a book on Lawyers and Their Society, which will be a comparison of the legal profession in Germany and in the United States.

ROBERT B. SEIDMAN is Professor of Law at the University of Wisconsin Law School. His primary interests are in the areas of African Law and Social Change and Law and Development. He is now preparing teaching materials in African Law and Development.
