

(1990), and Andrew Debicki was elected to a two-year term (1990–91).

22. *1991 Convention Site*. The council selected San Francisco as the site of the 1991 MLA convention.

23. *Correspondence from Members*. In response to a member's letter of complaint regarding housing at the convention, the council asked the staff to investigate the possibility of obtaining more hotel suites at the convention hotels. After discussion of a letter from a member requesting that the association become involved in a dispute about hiring procedures, the council reaffirmed the MLA's practice of not investigating individual cases of this sort due to a lack of resources and a lack of authority.

24. *February 1990 Council Agenda*. The council scheduled a discussion of the effects of demographic changes on the academic job market and the undergraduate population for its February meeting. An invitation to participate in this discussion will be extended to William Bowen, president of the Mellon Foundation and author of a study on the subject.
