The rise of socialist realism in the Soviet Union has meant the eclipse of Russia's humanist tradition and the repudiation of the classical inheritance. The new literature's protagonist—conformist and doctrinaire, limited and energetic, humorless and optimistic—is the new image of the human personality produced and widely celebrated in this century. Professor Mathewson traces the development of this literary archetype from his controversial first appearance in the mid-nineteenth century as the New Man, the revolutionary's counterstatement to the tragic figures of Russia's greatest literature, to his coming to power as the favored legatee of today's Communist rulers. This penetrating and integrating study of the making, and unmaking, of a literature is an important essay in the history of ideas.
