THE CONTRIBUTORS

BRUCE F. JOHNSTON, Associate Professor at the Food Research Institute, Stanford University, served as chief of the Food Branch, Price and Distribution Division of the Economic and Scientific Section of SCAP in Tokyo, and later as an agricultural economist with the U.S. Mission to NATO and European Regional Organizations in Paris. He is co-author of *Japanese Food Management in World War II* (1953).

QUINCY WRIGHT, Professor Emeritus of International Law at the University of Chicago, is currently Visiting Professor of International Law at the School of International Studies, University of Delhi, India. The most recent of his many books is *The Study of International Relations* (1955).

KLAUS KNORR is Professor of Economics and Associate Director of the Center of International Studies at Princeton University. He recently published *The War Potential of Nations* (1956) and contributed to *Military Policy and National Security*, edited by William W. Kaufmann (1956).

GORDON WRIGHT, Professor of History at Stanford University, is the author of *The Reshaping of French Democracy* (1948) and a contributor to *Modern France: The Problems of the Third and Fourth Republics*, edited by E. M. Earle (1951).

CHARLES WOLF, JR., a member of the Economics Division of The RAND Corporation, was associated with U.S. Foreign Assistance Programs from 1950 through 1953. He is the author of *The Indonesian Story* (1948) and co-author, with Sidney C. Sufrin, of *Capital Formation and Foreign Investment in Underdeveloped Areas* (1955).

FRED A. SONDERMANN is Assistant Professor of Political Science at The Colorado College. During the past academic year he was a Ford International Relations Fellow at Stanford University, studying the relationship between the behavioral sciences and international relations.

BERNARD BRODIE is a Senior Staff Member of The RAND Corporation. He is the author of *A Guide to Naval Strategy* (3rd ed., 1954) and co-author of *The Absolute Weapon: Atomic Power and World Order* (1946).

TALCOTT PARSONS is Professor of Sociology at Harvard University and has been a Marshall Lecturer in Economics at Cambridge University. He is co-author, with Neil J. Smelser, of *Economy and Society: A Study in the Integration of Economic and Social Theory* (1956).

HERBERT H. HYMAN, Professor of Sociology and Associate Director of the Bureau of Applied Social Research at Columbia University, will be Visiting Professor of Research Methods in Sociology at the University of Ankara, Turkey, during the current academic year. Among his publications are *Survey Design and Analysis* (1955) and *Political Socialization*, which will appear in 1958.

SAMUEL H. BEER is Professor of Government and General Education and Chairman of the Department of Government at Harvard University. The author of *Treasury Control: The Coordination of Financial and Economic Policy in Britain* (1956) and a contributor to *Modern Political Parties*, edited by Sigmund Neumann (1955), he is at work on a book dealing with British parties and pressure groups.

ROBERT S. MERRILL is Research Assistant at the Research Center for Economic Development and Cultural Change of the University of Chicago and Associate Editor of its journal, *Economic Development and Cultural Change*. He is engaged in an analysis of theories dealing with the role of social and cultural factors in economic growth.
