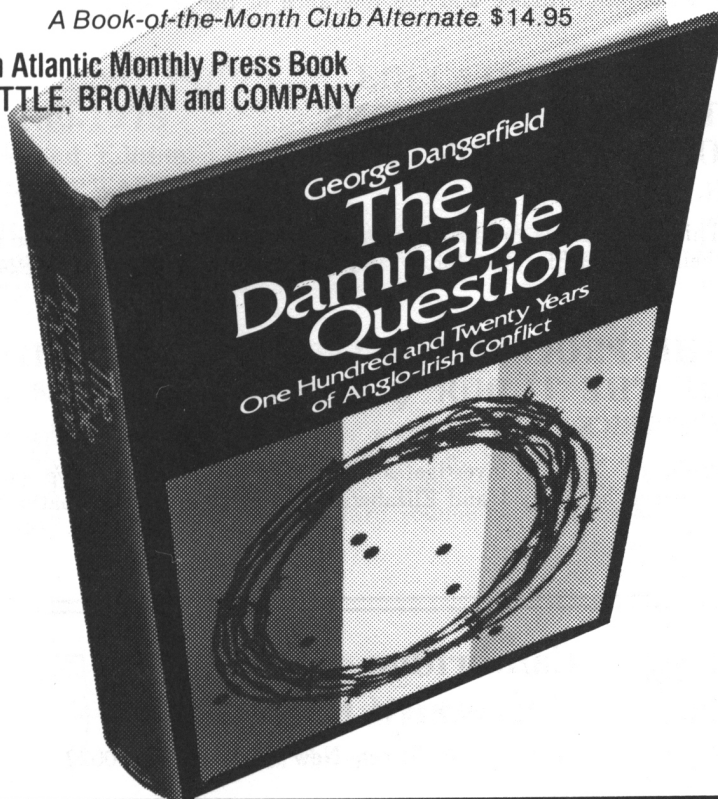

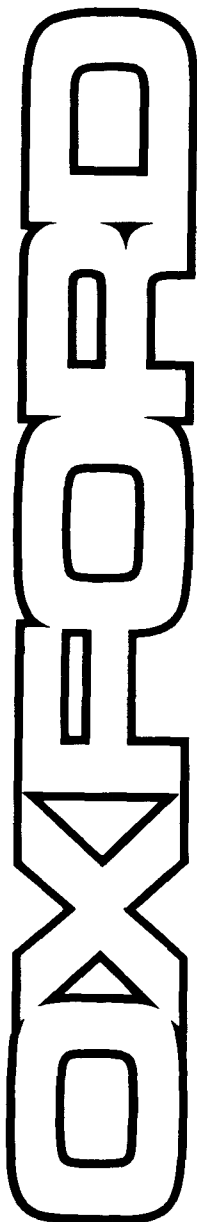

At a time when job placement is slow and difficult, the advantages of a specialized professional association increase. The Conference on British Studies cannot offer jobs but it does provide younger scholars — historians, scholars of English literature and of political science — with facilities for acquaintanceship, professional contact, and publication within their various disciplines. It supports two journals, holds two national and many more regional meetings each year, and maintains a policy of keeping a place for recent degree holders on its own programs and in its sessions at the American Historical Association. It will have this year a second session at the A.H.A. exclusively for recent Ph.D.'s in British Studies to discuss their thesis research. It publishes a review of current research in British Studies and sponsors the publication of short book-length monographs.

To make membership easier for scholars about to finish a degree, the C.B.S. has established an introductory graduate student membership which costs \$5 per year instead of the usual \$8. It is available for a single three-year term. All you need to do is write the Treasurer of the C.B.S. and request a dues form. His address is: Professor Stuart E. The Journal of British Studies, founded in 1961, is published at Trinity College under the auspices of the Conference on British Studies. It was the result of the imaginative generosity of a Trinity alumnus, Frederick E. Hasler (Hon. LL.D. 1957) who contributed funds to the College for the specific purpose of establishing a learned periodical in the field of British history. Several Trinity alumni subsequently contributed to the fund and Trinity College now supports the publication of the *Journal*.

The Conference on British Studies is the official organization in the United States and Canada of scholars working in the field of British history and culture; its status as such is recognized by the American Historical Association of which it is an affiliate. Its nearly eight hundred members are drawn from fifty states and five provinces. It convenes twice each year, usually at New York University. The Conference awards a prize every five years for the best first book by an American or Canadian scholar.

The Conference sponsors a considerable publications program. It publishes the *Journal of British Studies* at Trinity College; the *British Studies Intelligencer*, a newsletter, at Western Washington State College, Bellingham, Washington; and *Archives in British History and Culture*, a series devoted to the publication of documents, at West Virginia University, Morgantown; and *Current Research in British Studies*, a quadrennial survey of research in progress in the United States and Canada, published at Kansas State University, Manhattan, Kansas and edited at Western Washington State College. The Conference also sponsors a series of short monographs, *Studies in British History and Culture*, edited at Wittenberg University, Springfield, Ohio and published by the Shoe-String Press, Hamden, Connecticut. Under the aegis of the Conference, Cambridge University Press publishes a bibliographical and biographical series. *Albion*, including the proceedings of the Conference in its regional and national meetings, is published four times a year at Appalachian State University, Boone, North Carolina, and is sent to all members of the Conference.

In addition to the Conference on British Studies, there are several affiliates: the Pacific Coast Conference on British Studies, the Pacific Northwest Conference on British Studies, the Midwest Conference on British Studies, the Southern Conference on British Studies, and the New England Conference on British Studies. Each of these vital autonomous groups has its own officers, programs, and other activities. There are also local groups centered in Los Angeles, Detroit, Pittsburgh, and San Francisco.

The Journal of British Studies appears twice in the academic year, in the autumn and in the spring. The annual subscription is \$8.00.
