Benji J.O. Anosike, an advanced doctoral candidate in Political Economy at the New School for Social Research in New York City, is an adjunct lecturer in the department of Afro-American Studies, New York City Community College. His main research interests are in Economic Development theory and planning. A frequent contributor to publications, his most recent article is "Jencks Harvard Study Revisited", in *The Educational Forum* (Ohio University), May 1975.

Pauline H. Baker is a professional staff member of the Senate Foreign Relations Committee with principal responsibility for African affairs. She lived in Africa for 11 years and was formerly a lecturer at the University of Lagos. Under the auspices of the Rockefeller Foundation, she conducted research in southern Africa in 1975 and 1976. She is the author of *Urbanization and Political Change: The Politics of Lagos* and several articles on Africa.
