The 1968 Meeting of the American Philosophical Association, Western Division, will be held in St. Louis. The dates will be May 2-4, 1968.

The Program Committee welcomes papers in any of the areas of philosophy. Except for specially arranged symposium contributions, papers are limited to 20 minutes reading time. Preference will be given to papers submitted in their entirety, but drafts or even abstracts alone will be considered in exceptional cases. Papers already accepted for publication will be considered, provided they are not appear in print before June, 1968. (In submitting a paper already accepted for publication, indicate where and when it is to be published.)

The deadline for volunteered papers will be December 1, 1967. All papers should be sent to the Secretary, Gerald C. MacCallum, Jr., Department of Philosophy, Bascom Hall, University of Wisconsin, Madison, Wisconsin, 53706.

Persons offering papers should submit three copies, as well as three copies of an abstract of not more than 300 words. Abstracts of papers accepted for presentation will be printed in the program of the Annual Meeting.
