Offers United States Political Science
Documents Data in Machine-Readable Form**

The University Center for International Studies announces the availability of its *United States Political Science Documents* (USPSD) in machine-readable form. Institutions interested in non-commercial service and research uses of USPSD can now acquire it in a form appropriate for computer-based processing.

USPSD is devoted to the intensive coverage of journal articles published in the United States which are of interest to political scientists and students and scholars in allied fields. Each article covered is described by means of a complete author, titles and journal citation together with an abstract, the names of all cited people, and the likes of all special features such as tables, figures, charts, and the like. Moreover, the *Political Science Thesaurus*, developed at the University of Pittsburgh under the auspices of the American Political Science Association and with funding from the National Science Foundation, is used to effect both subject and geographic area vocabulary control. A list of project names (notable events, articles of legis-

lation, names of organizations, etc.) is also provided.

Volume I of USPSD contains complete descriptions of 4,494 articles published in 1975. Volume II covers 2,824 articles from 1976. Volume III is currently in process and is projected to include 3,500 articles from 1977. Each Volume is priced at \$3,000 but for a limited time *both* Volume I and II, which are available now, can be purchased for \$3,000. When Volume III is completed in the fall of 1978, it will be priced at \$3,000 and the introductory offer for Volume I and II will be ended. A sample file of 100 USPSD entries is available for \$50, the cost of the tape and its handling and mailing.

Pollution Decisions and Representation: A Policy Process Approach, conducted by Donald C. Menzel, West Virginia University.

The workshop introduces faculty to a new instructional unit whose primary purpose is to teach analytical thinking in a problem-centered context. The unit requires the student to work through a problem facing many communities—snow for weeks on city sidewalks. An interactive instructional methodology called Guided Design is used throughout most of the module. Students work in small groups on the problem and are guided by each other, the instructor and printed material in the form of instructions and feedback. The instructions-feedback are carefully sequenced so as to provide the groups with a step-by-step treatment of the problem.

The unit concludes by challenging this information processing approach and recasting the problem in terms of class analysis. The exercise is designed to be completed in two weeks. The unit can be used in courses in public policy, state-local politics, and in the introductory course in political analysis.

Police Discretion, conducted by Erika S. Fairchild, North Carolina State University.

This workshop will focus on the three main objectives of this new Supplementary Analytical Unit: (1) To provide a progressively intense analysis of police discretion within the context of police organization and democratic society; (2) To explore and evaluate the applicability of a few major social science research paradigms to the topic of police discretion; and (3) To promote discussion, collective decision-making and collective production of reports through the use of interactive exercises done in teams of four to five students.

The unit is accompanied by an Instructor's Manual, designed to identify the objectives of each chapter and exercise and to provide the instructor with tentative analyses of the various readings included in the module. Participants will receive a copy of the module.
