RACHEL A. SCHURMAN is Assistant Professor of Sociology at the University of Illinois. Her areas of interest include environment and development in Latin America, political sociology, and most recently, biotechnology in agriculture and aquaculture.

CARMEN DIANA DEERE is Professor of Economics and Director of the Center for Latin American, Caribbean, and Latino Studies at the University of Massachusetts, Amherst. **MAGDALENA LEON** is a professor on the Faculty of Humanities and Social Sciences at the Universidad Nacional de Colombia in Bogotá. They coedited *Rural Women and State Policy: Feminist Perspectives on Agricultural Development in Latin America*. They have also coauthored several other books on rural women, including *Gender, Property, and Empowerment: Land, State, and Market in Latin America*, forthcoming from the University of Pittsburgh Press.

DAVID CLEARY earned a Ph.D. in anthropology at Oxford in 1988 and has shuttled between the academy, project management, and the nonprofit world ever since. He is now permanently based in Brasília, where he directs The Nature Conservancy's program in the Brazilian Amazon (dcleary@tnc.org).

KENT EATON is Assistant Professor of Politics and International Affairs at the Woodrow Wilson School at Princeton University. He has written on economic reform in the Argentine and Philippine legislatures and will be publishing an article on the relationship between democratization and fiscal decentralization.

A senior researcher at the Casa de Oswaldo Cruz in Rio de Janeiro, **MARCOS CHOR MAIO** earned a Ph.D. in political science from the Instituto Universitário de Pesquisas do Rio de Janeiro (IUPERJ). He has published many articles and a book on race, ethnicity, Brazilian social thought, and the history of Brazilian social sciences. He coedited *Raça, ciência e sociedade* with Ricardo Ventura Santos and *Ideais de modernidade e sociologia no Brasil* with Glaucia Villas Boas. His current research concerns the history of efforts between 1946 and 1951 to create the first international laboratory in the Amazon, sponsored by UNESCO.

HARRY SANABRIA is an associate professor of anthropology at the University of Pittsburgh. He is currently engaged in a longitudinal research project focused on the intersection of demographic processes, political-economic trends, and kinship practices in patterns in Cochabamba, Bolivia, from the early nineteenth century to the latter half of the twentieth century.

JOHN C. DUGAS is an assistant professor of political science at Kalamazoo College. He is the coauthor of *Los caminos de la descentralización: Diversidad y retos de la transformación municipal* and editor of *La Constitución de 1991: ¿Un pacto político viable?*, both published by the Universidad de los Andes in Bogotá.

BRIAN F. CRISP is Associate Professor and Director of Graduate Studies in the Department of Political Science at the University of Arizona. His work on the institutional mechanisms constructed to formalize state–civil society relations and the impact of these relations on policy choices has appeared in *Legislative Studies*

Quarterly, *International Studies Quarterly*, *Studies in Comparative International Development*, *Journal of Interamerican Studies* and *World Affairs*, and *LARR*. His book, *Democratic Institutional Design: The Powers and Incentives of Venezuelan Politicians and Interest Groups*, was recently published by *Stanford University Press*. He is currently completing a collaborative project on forms of representation in the legislatures of six Latin American countries.

MARIA ESCOBAR-LEMMON is Assistant Professor in the Department of Political Science at *Texas A & M University*. Her current research focuses on relations among levels of government (questions of federalism and decentralization) and national-level legislators' interest in programmatic forms of representation versus parochial forms.

PETER M. BEATTIE is Assistant Professor of History at *Michigan State University*. His forthcoming book, *Tribute of Blood: Army, Honor, Race, and Nation in Brazil, 1846–1945*, will be published by *Duke University Press*.

PHILIP SWANSON is Professor of Hispanic Studies at the *University of Aberdeen*, where he serves as Head of Department and Director of the Centre for the Study of Culture and Power in the Global System. He has written numerous works on Latin American literature, including books on modern fiction, José Donoso, and Gabriel García Márquez. His most recent book is *The New Novel in Latin America: Politics and Popular Culture after the Boom*.

AMY KAMINSKY is Professor of Women's Studies at the *University of Minnesota*. She has written widely on issues of gender and sexuality, most notably in *Reading the Body Politic: Feminist Criticism and Latin American Women Writers*. Her most recent book is entitled *After Exile: Writing the Latin American Diaspora*.

ROBERT WHITNEY is Assistant Professor of Latin American History and International Studies at the *University of New Brunswick at Saint John, Canada*. He has written several articles on Cuban history as well as *State and Revolution in Cuba: Mass Mobilization and Political Change, 1920–1940*, forthcoming from the *University of North Carolina Press*.

ANNA PETERSON is Associate Professor in the Department of Religion at the *University of Florida*. Her research focuses on religion and politics in Latin America and on social and environmental ethics. She is the author of *Martyrdom and the Politics of Religion: Progressive Catholicism in El Salvador's Civil War* and a forthcoming book on environmental ethics. She also coedited the forthcoming *Christianity, Social Change, and Globalization in the Americas*.
