The journal discusses not only criminal law, but also civil law matters, into which category most legal rules fall. As well as papers dealing sociologically with the contemporary situation, the journal includes historical and anthropological contributions. Both research results and theoretical arguments are published, as well as critically descriptive analyses.

A particular feature of the journal is that it emphasises academic debate. Replies to articles and reviews and review symposia are encouraged. Thus, although the journal is primarily radical in orientation, discussion is encouraged from a variety of different standpoints. The 1981 issue (volume 9) will include replies by James Brady and Ulrich Preuss to the contributions of Beristain and Nagel, thus extending the debates on problems of professionalism and international terrorism. In addition, there will be a special issue on law and energy. Contributions from scholars in third world nations as well as from the developed nations of both East and West will continue to be published, emphasising the international relevance of academic debate in this field.

The journal therefore appeals not only to sociologists and anthropologists, including those who are not specialists in the substantive field, but also to criminologists and lawyers. It will involve an international group of scholars in theoretical debates, and enable readers to assess the general relevance of particular national issues.
