**CHIEF OF THE CLINICAL  
BIOETHICS PROGRAM**

The Chief of the Clinical Bioethics Program, Clinical Center, serves as principal advisor to the Director, Clinical Center and Institute Clinical Directors on matters related to the ethical aspects of patient care and the conduct of research involving human subjects. The Chief will provide direction and overall management and supervision of this program.

This is a Civil Service position in the Senior Executive Service (SES) with an annual salary between \$97,991 to \$122,040. In addition, physicians may be eligible for a Physicians Comparability Allowance up to \$20,000 per annum. A recruitment bonus of up to 25 percent of base pay may be available to a non-Federal candidate, subject to individual approval; a relocation bonus of up to 25 percent of base pay may be available to a permanent Federal employee who must relocate, subject to individual approval. (Applicants alternatively may be eligible for appointment in the Commissioned Corps of the U.S. Public Health Service.)

Applicants must meet the minimum educational requirements for Medical Officer Series, GS-602, General Health Science Series, GS-601 or Social Science Series, GS-101. Applicants must further meet established mandatory professional/technical and executive core qualifications requirements. ## THE SOCIETY

The American Society of Law, Medicine & Ethics (ASLME) is an interdisciplinary educational association whose mission is to provide high-quality debate and critical insights on issues facing the community of professionals at the intersection of law, health care, policy, and ethics.

## PUBLICATIONS

Membership in ASLME includes annual subscriptions to two quarterly publications: *The Journal of Law, Medicine & Ethics* (formerly *Law, Medicine & Health Care*) and the *American Journal of Law & Medicine*.

*The Journal of Law, Medicine & Ethics* is a professional, peer reviewed quarterly read by more than 6,500 doctors, lawyers, nurses, ethicists, hospital administrators, allied health professionals, and students. *JLME* provides well-written and often controversial articles on such timely topics as health care standards and access, managed care, ethics committees, consent, assisted dying, genetic technology, reproductive freedom, and public health concerns. The Summer 1995 issue features papers on decision making for incapacitated adults, model health insurance reform, genetics and discrimination, and administrative health care costs. *The American Journal of Law & Medicine* is a law review co-published with the Boston University School of Law. *AJLM* was founded to fulfill the need for a scholarly journal dedicated to improving communication between legal and medical professionals. Each issue contains in-depth articles and case notes—on broad themes relating to health law and policy, and to the legal, ethical, and economic aspects of medical practice, research, and education—and selected book reviews and health law court decisions.

The Spring 1995 issue features papers on safeguards on commercialized organ transplantation and telemedicine and rural health care.

## CONFERENCES

## SUBMISSION OF MANUSCRIPTS

The editors encourage the submission of manuscripts on a wide range of medicolegal topics for publication in the JOURNAL. Acceptable subjects include health law and policy; legal, ethical, social, and economic aspects of medical practice, education, and research; health-related insurance; and other important or interesting subjects involving the relationship of the life sciences to the social sciences and humanities. The JOURNAL is interdisciplinary. Contributions from specialists in a variety of disciplines are welcomed.

**ADDRESS:** All materials should be sent to the Editor-in-Chief, AMERICAN JOURNAL OF LAW & MEDICINE, Editorial Offices, 765 Commonwealth Avenue, Suite 1672, Boston, Massachusetts, 02215.

**GENERAL FORM:** Manuscripts must be in typed form and single-sided. They must be double-spaced, with liberal margins. Manuscripts should be submitted in *triplicate*, i.e., an original and two photocopies. The title of the paper and the author's name and address should be given only on the covering sheet. Papers should exceed forty pages in length. If a paper is accepted, the author will be expected to provide a diskette copy of the manuscript either in MS Word 2.0 or WordPerfect 5.1 or 6.0.

**ABSTRACTS:** A short abstract (normally of no more than 200 words), succinctly summarizing the content of the manuscript, should accompany the manuscript on a separate sheet. If a manuscript is accepted, its abstract will be published with the paper.

**REFERENCES:** Footnotes to sources must be numbered consecutively and double-spaced. All footnotes should conform to *A Uniform System of Citation* (15th ed.), which is published and distributed by the Harvard Law Review Association, Gannett House, Cambridge, Massachusetts 02138. Nonlawyers unfamiliar with this system should follow the citation form accepted in their discipline. If such a paper is accepted, the editors of the JOURNAL will work by arrangement with the author to convert the footnotes into the proper form.

**ILLUSTRATIONS:** All illustrations, tables, graphs, and charts must be numbered and given suitable legends. Authors must indicate in the manuscript the appropriate positions of such graphics. Authors will be expected to provide either a suitable diskette graphics file or a camera-ready copy for each graphic.

**SELECTION AND EDITING TIMETABLE:** On receipt, the editors will acknowledge the submission of manuscripts. Authors will be notified of manuscript decisions within one to three months of receipt, depending on the length of the manuscript. Accepted manuscripts will be published as quickly as possible, usually within three to eight months of acceptance.

**PROOF PAGES AND AUTHOR REPRINTS:** Authors will be given *one* set of proof pages prior to publication. Proof pages will incorporate textual revisions discussed between the assigned editor and the author. Reprint order forms will accompany the proof pages. All orders must be prepaid.

**RETURN OF MANUSCRIPTS:** For file purposes, the JOURNAL retains one copy of all papers submitted for consideration. Copies are not returned to an author unless the author so requests in writing and supplies the JOURNAL with a return address envelope and adequate postage.
