**A Bibliography of Caribbean Migration

The bibliography, containing 2,585 citations and 339 pages, is the first attempt to bring together pertinent historical and contemporary literature dealing with the massive migration of peoples into, within, and out of the Caribbean region. The physical area covered, defined geographically and culturally, includes the Caribbean archipelago and its linguistic groups, as well as the mainland territories of Belize, Guyana, Suriname, and French Guiana. Citations include references to books, anthologies, articles in the academic and popular press, and governmental reports in the following languages: English, French, Spanish, Dutch, German, Italian, Slovak, Polish, and Welsh. Both published and unpublished work is cited. Every attempt has been made to reference all disciplines and topics, including international migration, intraregional migration, the impact of migration on the sending and receiving societies, rural out-migration and urbanization. Works dealing with the African slave trade have been excluded. The bibliography is arranged alphabetically by author and there are four appendices providing cross references for Second Authors, Origins of Migrants, Destination of Migrants, and a Topical Index. Two additional appendices list the data bases searched and the journal titles cited.

NOTES ON THE CONTRIBUTORS

JOSE MARIA CABALLERO is an agricultural economist with the Food and Agriculture Organization of the United Nations and was formerly affiliated with the Centre of Latin American Studies at the University of Cambridge. He also has taught at the Catholic University in Lima and carried out research for the Instituto de Estudios Peruanos. He has written three books and several articles on the Peruvian agrarian sector and development issues.

JOHN R. HALL has written a series of essays on the epistemology of the social action perspective. His empirical research has ranged from studies of migrant farmworkers to a book on utopian communal groups. He is currently writing a book on the People's Temple.

CANDACE SLATER is Watkins Assistant Professor of Humanities at the University of Pennsylvania. She has held Guggenheim, Tinker, NEH, and Gulbenkian fellowships. She published *Stories on a String: The Brazilian Literatura de Cordel* and is presently completing a book on pilgrim narratives tentatively entitled *Trail of Miracles: The Padre Cícero Stories of Northeast Brazil*.

SEYMOUR MENTON is Professor of Latin American Literature at the University of California at Irvine. He wrote *Historia crítica de la novela guatemalteca* and coauthored the 1973 LASA ad hoc committee report on Guatemala. He also has published books on the fiction of Colombia, Costa Rica, and the Cuban Revolution. The final research for this study was carried out in Guatemala City during the summer of 1981.

BRENDA GAYLE PLUMMER is Assistant Professor of Afro-American History at the University of Minnesota. Her research interests include Caribbean history.

LISANDRO PEREZ is Associate Professor of Sociology at Louisiana State University. His general area of interest is the Hispanic Caribbean. His published research has focused primarily on the development of Cuba's population, both on the island and in the United States.

JOHN C. SUPER is Associate Professor of History at West Virginia University. He has written on the early history of Mexico and Ecuador and is currently finishing a study of food and the conquest and colonization of Latin America.

RICHARD A. DIEHL is Professor of Anthropology at the University of Missouri-Columbia. His speciality is the archaeology of pre-Columbian Mesoamerica, where he has conducted investigations during the past twenty years.
