***Race, Culture, and Portuguese Colonialism
in Cabo Verde***

Deirdre Meintel

Syracuse University's Maxwell School has published the first complete ethnography of the Cape Verde Islands, an Atlantic archipelago that was for centuries a point of transshipment for slaves being taken to the Americas. Of all Portugal's colonies, Cabo Verde seemed to best exemplify Freyre's "Lusotropicalism." As in Brazil, extensive miscegenation, a fluid and complex system of racial categories, and the absence of legalized discrimination all seemed to preclude the existence of a color bar. This study demonstrates that in fact, a racial hierarchy flourished, legitimized by certain notions of "culture" on both the popular and official levels. At the same time, it shows how "culture," notably in the areas of language and religion, became an arena of popular resistance to colonial hegemony.

In naming *Race, Culture, and Portuguese Colonialism in Cabo Verde* one of 1985's Outstanding Academic Books, *Choice*

magazine described it as "a fascinating portrait of daily life in a Portuguese-African milieu.... an extremely worthy addition to the literature on the Portuguese-speaking world."

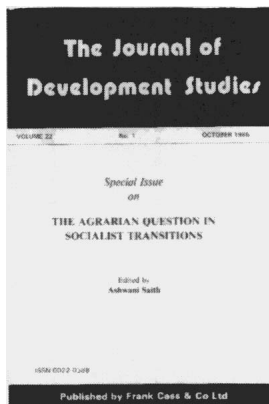
