She edited “Mitteleuropa” und “Südosteuropa” als Planungsraum. *Deutsche und österreichische Expertisen im Zeitalter der Weltkriege* (Göttingen: Wallstein Verlag, 2010) and coedited *Politics and Science in Wartime: Comparative Perspectives on the Kaiser Wilhelm Institutes*, Osiris 20 (Chicago: University Press, 2005); *Nationen und ihre Selbstbilder. Postdiktatorische Gesellschaften in Europa* (Göttingen: Wallstein, 2008); and *The Kaiser Wilhelm Society under National Socialism* (Cambridge: Cambridge University Press, 2009).

ATINA GROSSMANN is a professor of history in the Faculty of Humanities and Social Sciences at the Cooper Union in New York City (ag93@nyu.edu, grossm@cooper.edu). Her publications include “Jews, Germans, and Allies: Close Encounters in Occupied Germany” (Princeton, NJ: Princeton University Press, 2007); and *Reforming Sex: The German Movement for Birth Control and Abortion Reform, 1920–1950* (Oxford: Oxford University Press, 1995). She coedited volumes on *Crimes of War: Guilt and Denial in the Twentieth Century* (New Press, 2002); and *After the Nazi Racial State: Difference and Democracy in Germany and Europe* (Ann Arbor, MI: University of Michigan Press, 2009). She is beginning a research project on “Soviet Central Asia, Iran, and India: Sites of Refuge and Relief for European Jews during World War II.”

MARY NOLAN is a professor of history at New York University (Department of History, NYU, 53 Washington Square South, 7th floor, NY, NY 10012; e-mail: mn4@nyu.edu). She is the author of *Visions of Modernity: American Business and the Modernization of Germany*. She is coeditor with Omer Bartov and Atina Grossmann of *Crimes of War: Guilt and Denial in the Twentieth Century* and coeditor with Monika Kraus, Michael Palm, and Andrew Ross of *The University against Itself: The NYU Strike and the Future of the Academic Workplace*. Recent book chapters are “Americanization as a Paradigm for German History,” in *Conflict, Catastrophe, and Continuity in Modern German History*, and “Varieties

of Capitalism and Versionen der Amerikanisierung,” in *Gibt es einen deutschen Kapitalismus? Tradition und globale Perspektiven der sozialen Marktwirtschaft*. Recent articles include “Air Wars, Memory Wars,” in *Central European History*, and “Anti-Americanism and Americanization in Germany,” in *Politics and Society*. She is completing a book on Europe and America in the twentieth century.

TARA ZAHRA is an assistant professor of history at the University of Chicago (1126 E. 59th Street, Chicago, IL 60637; e-mail: tzahra@uchicago.edu). She is the author of *Kidnapped Souls: National Indifference and the Battle for Children in the Bohemian Lands, 1900–48*, which was awarded the Hans Rosenberg Prize of the Conference Group for Central European History, the Barbara Jelavich Prize of the AAASS, the Czechoslovak Studies Association Book Prize, and the Austrian Cultural Forum Book Prize. Her next book, *The Lost Children: Reconstructing Europe's Families after World War* will be published by Harvard University Press in spring 2011. She is currently working on the history of emigration and immigration in Austria-Hungary, and on the history of the family in postwar eastern and western Europe.

The journal solicits manuscripts using all approaches to history and dealing with all historical periods. Because space is limited, articles which have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editors prefer that manuscripts be submitted in electronic form as e-mail attachments sent to the journal's address, preferably in Microsoft Word 2003 or later or WordPerfect 12.0 or later; Adobe Acrobat pdf files will also be reviewed. Manuscripts submitted in printed form must be accompanied by a compact disk or diskette with the article in Word, WordPerfect, or pdf. The entire text of all manuscripts, including footnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Footnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
