ROBERT LEWIS BONN is Assistant Professor of Sociology at the John Jay College of Criminal Justice, City University of New York. He received the Bobbs-Merrill Award in Sociology in 1970 and last year presented papers at the annual meetings of the Eastern Sociological Society and the American Sociological Association.

BRADLEY C. CANON is Associate Professor of Political Science at the University of Kentucky. Among his publications is "Compliance with Gault in Rural America," which appeared in the *Journal of Family Law*, Winter 1970-71. He has published a number of articles on state supreme courts and during the 1972-73 academic year he will be engaged in a study of the *Mapp* exclusionary rule on police search and seizure behavior.

BEVERLY BLAIR COOK is Associate Professor of Political Science at the University of Wisconsin Milwaukee.
