ballot. Ballots will be distributed within 30 days of the Annual Business Meeting by the executive director. They must be returned within 30 days following distribution.

The 1986 Annual Business Meeting rules are printed in the Features section of this issue of *PS*. The rules require that any nominations in addition to those made by the Nominating Committee must be received in writing at the Association's Washington office prior to Monday, August 25, 1986, or thereafter at the Association's annual meeting office in the hotel headquarters. All such nominations and certifications must be received at least 24 hours before the session of the Annual Business Meeting in order to include those names on the original nominating document. Specific procedures for offering nominations are indicated in the Annual Business Meeting rules.

In offering the report of your nominating committee, I would like to make three points:

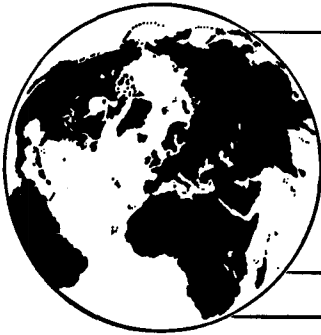

think what mattered most to us was that as many members of the Association as possible might be able to reach out and touch some sitting member of the Council, so that suggestions, or opinions, or grievances from as broad a population of members as possible might reach the Council and inform their deliberations. So we hope you will read our selections for this year's nominees in the context of the full Council of which they will be a part. Among the characteristics of nominees that we thought important were these: diversity of geographic location, of sub-field, of personal attributes such as age, gender and race, of job characteristics such as teaching versus non-teaching, and if teaching, whether in public or private, secular or religious, large or small, rural or urban settings. All these varied characteristics of our members signal a variety of life experiences and concerns that, in some way or another, we wanted to respond to in the nomination process and express in our eventual choices. We are conscious of the fact

that the shortcomings of our efforts can be and no doubt will be compensated for by the work of our successor committee next year.

(3) In spite of our inability to maximize with equal effectiveness in all directions, we are delighted with the group of nominees that we finally selected. The enthusiasm that many of them have expressed at the prospect that they might serve our Association was very heartening indeed to the committee. That so many talented political scientists are willing to serve is a wonderful sign of the health of our collective enterprise. □
