### SHEA Comments to HCFA About Hospital-Based Performance Measures

SHEA's president and its Performance Improvement Committee recently authored a thoughtful letter to the Health Care Financing Administration (HCFA), stimulated by the recent *Federal Register* publication of a proposed rule on Hospital Conditions of Participation (COP); Provider Agreements and Supplier Approval for Medicare and Medicaid Programs (42 CFR Part 416, 482, and 485).

SHEA's general comments expressed satisfaction that, ". . . HCFA has decided *not* to include in the hospital COPs any requirements for hospitals to collect and report standard data items (eg, nosocomial infection rates, medication errors), that HCFA states "could provide quality care predictors in the future," because ". . . at this time . . . of the lack of any current consensus or science that could establish a reliable and valid set of measures."
