## **A Religious History of the American People**

Starting with a thorough description of the European antecedents that shaped religious life in young America, Mr. Ahlstrom explores our religious history within the context of social, political, and intellectual development. In doing so he makes pertinent judgments and interpretations that avoid the parochialism of the conventional church history.
