Some emphasis is placed on the development of ideas in education, though many selections also deal with the social and institutional aspects of American schools. The editors have been especially sensitive to historical interpretation both in their introductory essays and in their selection of readings, with the result that a high level of sophistication is maintained throughout. Arrangement is chronological, from Colonial Times to the present.
