**Amsterdam, 26-28 April 1995**

The year 1995 will mark the fiftieth anniversary of the end of World War II. The occasion will be celebrated by the Netherlands State Institute for War Documentation in Amsterdam with a three-day conference on Memory and the Second World War in International Comparative Perspective. The conference is organized in collaboration with the Institute for the History of European Expansion (Leyden University), Women's Studies (Utrecht University), and the Rutgers Center for Historical Analysis (USA).

Themes of the conference are:

- 'Memory and the Holocaust'
- 'Gender and the Memory of the Second World War'
- 'National and Post-National Memory and the Second World War: Western Europe, the United States, and Eastern Europe'
- 'Memory in the Pacific and the Second World War'
- 'National and Post-National Memory and the Second World War during and after Decolonization: Western Europe, the United States, and the Pacific'

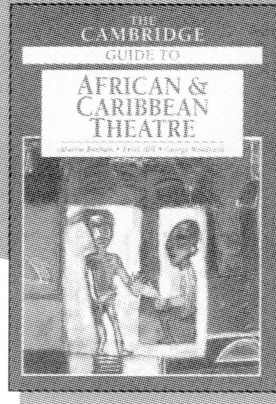
