The Malice of Empire presents a dramatic episode in Chinese palace politics during the last years of the nineteenth century. The play centers on the malicious persecution of the young Emperor by the Manchu Empress Dowager as she attempts to retain control of the Empire. Based on historical events, the play analyzes the psychology of tyranny and indicts despotism. First performed in Shanghai in 1941, it was proscribed in 1942 by Japanese Occupation order and in 1949 by Mao Tse-tung. In 1967 support for the play in any form became an "act of treason" in mainland China.

The time of *Shore of Pearls* runs from earliest antiquity down to the end of the "Northern Sung" period—until about the second decade of the twelfth century. The emphasis, however, is on the period from the eighth to the eleventh century, when information about Hainan was beginning to become abundant. The author has relied on contemporary sources throughout, but, as he notes, "it has been impossible to neglect the descriptive material in encyclopaedic sources of the 'Southern Sung' period."

THE PIVOT OF THE FOUR QUARTERS: A Preliminary Inquiry into the Origins and Character of the Ancient Chinese City by *Paul Wheatley, Professor of Geography, University of London.*

In this work, one of the world's most distinguished scholars presents a summary of the wealth of evidence pointing to the distinctive nature of the earliest Chinese cities, while isolating and analyzing the cross-cultural regularities these cities share with urban forms in other cultures. The result is a major contribution to the history and theory of urbanism. Professor Wheatley presents sufficient evidence to explain the beginnings of Chinese cities themselves and to compare these cities with other areas of nuclear urbanism. His book begins with an investigation of the earliest cities in China during the Shang periods (1750-1150 B.C.) and the subsequent diffusion of urban forms during the Chou period. In the course of his investigation, the author defines the use and limitations of various kinds of evidence—archaeological, literary, and inscriptural—and shows how this kind of evidence used in an investigation will affect the generalizations reached. Archaeological evidence, for example, stresses technological innovation more than social or institutional change. Most important Professor Wheatley develops an original and coherent theory of urban genesis, cross-cultural and comparative in nature, and demonstrates the validity of including the Chinese city in these comparisons. 583 pp. \$12.50.
