Ellen Dwyer looks at the internal dynamics and multiple social functions of two nineteenth-century asylums: the New York State Lunatic Asylum at Utica (founded in 1843), and the Willard Asylum for the Chronic Insane (1869). Using a wide range of manuscript and printed records, she compares the history, clientele, and operation of these two New York State institutions. Dwyer offers a unique glimpse of life within nineteenth-century asylums, and offers a new perspective on the debate about their methods of social control.
