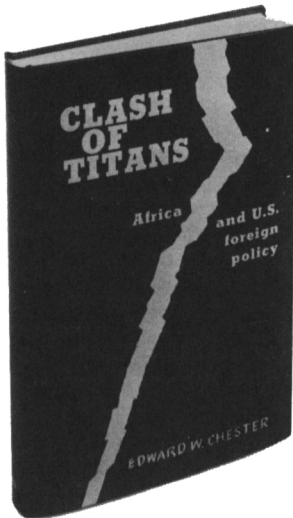

## INSTRUCTIONS TO CONTRIBUTORS

Contributions are welcome whether or not the author is a member of the Association. Manuscripts on any aspect of African affairs, including the relations of Africa and Africans with the rest of the world, are published in the Review. The Review publishes four types of manuscripts: (1) articles, which in most circumstances should not exceed 30 pages of copy, or about 7,500 words, that present new information, findings and interpretations of general interdisciplinary interest to African studies; (2) research notes, which present methodological issues of importance to current research on Africa; (3) teaching notes, which discuss new approaches to teaching about Africa at all levels of education; and (4) review essays that discuss and evaluate a set of new publications on a topic of general interest to African studies. Research notes, teaching notes, and review essays should not exceed 15 pages of copy, or about 3,700 words.

All manuscripts should be submitted in duplicate. They should be double-spaced and may be typed, mimeographed, hectographed, or in other legible form. Footnotes should appear at the end of the manuscript, not at the bottom of the page. Manuscripts are evaluated by the editors and other referees. To permit anonymity, attach a cover page giving title, authorship, affiliation, and proper mailing address. Only use the title as a means of identification on the manuscript itself. A Review Style Sheet may be secured from the Editors, or consult any issue of the Review, beginning with the September, 1974, issue (Volume 17, Number 2).

All editorial correspondence and manuscripts, with the exception of teaching notes and review essays, should be sent to The Editors, African Studies Review, Program of Eastern African Studies, Syracuse University, 119 College Place, Syracuse, New York, 13210, U.S.A. Correspondence concerning teaching notes should be sent to Mrs. Evelyn Jones Rich, School Services Division, African-American Institute, 833 United Nations Plaza, New York, N.Y., 10017. Correspondence concerning review essays should be sent to Hans E. Panofsky, M. J. Herskovits Library of African Studies, Northwestern University, Evanston, Illinois, 60201.

In order to protect the rights of the author and the Association, all material in the African Studies Review is copyrighted by the Program of Eastern African Studies, Syracuse University. Any author may republish his article in whole or in part without requesting permission from the Association. Others desiring permission to republish material should apply to the Editors. Contributors of articles receive 25 free reprints of their articles.

The African Studies Review is a publication of the African Studies Association. Receipt of the Review, the African Studies Newsletter, and Issue, (a quarterly journal of opinion on Africa) is automatic with Membership in the Association.
