## THE POLITICS OF EDUCATIONAL REFORM IN FRANCE, 1918-1940

JOHN E. TALBOT

The effort in France to democratize the educational system, particularly in the secondary schools, and to reform the traditional educational structure laid down by the Jesuits in the seventeenth century and completed by Napoleon and other reformers in the nineteenth century is described. The full background of political and social history in France between the two major wars of the twentieth century is considered, for no educational system can be understood in isolation from the society that creates it. The benevolently authoritarian political style of the Fifth Republic, for example, differs enormously from the ineffectual conduct of parliamentary politics under the Third Republic, and these conditions have impinged in quite different and drastic ways on the process of educational reform.

## THE FRENCH REPUBLIC UNDER CAVAIGNAC, 1848

General Louis Eugene Cavaignac has been a symbol of reactionary violence ever since he crushed the insurgent workers of Paris in the “bloody June Days” of 1848. Professor de Luna presents a fresh interpretation of the General, as well as a detailed examination of the turbulent year of European revolution until Cavaignac was defeated by Louis Bonaparte in the December presidential elections. Many historians have dismissed the Cavaignac period as one of bleak reaction, but Professor de Luna shows that the General was a fervent democratic republican, and the moderate republicans under Cavaignac offered their own program of political, economic, and educational reform.

#### NOTES FOR CONTRIBUTORS

Contributions may be descriptive, analytical or theoretical. Any article not in itself comparative may be accepted if it lends itself to comment that will place it in comparative perspective. Correspondence with the editors prior to the submission of articles will help to enable them to obtain such comment or a companion study. Emphasis in comparative studies may be either on similarities or, if these are significant enough and call for some recasting of generalisations, on differences. All contributions and editorial correspondence should be sent to the Editors, *Comparative Studies in Society and History*, Department of History, University of Michigan, Ann Arbor, Michigan 48104.

Two copies of each contribution, preferably accompanied by a stamped, addressed envelope, should be submitted. Both text and footnotes should be clearly typed with double spacing and wide margins; footnotes should appear on separate pages at the end of the article. Illustrations may be included by arrangement with the editors.

Contributors will receive 50 offprints bound in the journal covers. Any additional offprints must be ordered on receipt of the first proof.
