This up-to-the-minute investigation into the export trade in farm animals is written by CIWF's Political Director. Stevenson traces the history of the trade since the 1950s, uncovering the economic factors at play, and analysing how European Union rules have deepened the problem.

This book is a theological discussion about the place of animals in the world and the way in which Christian theology can contribute to a morally just treatment of them by human beings. It arises out of the first lectures on this subject ever given in the University of Oxford.

The first part contains specifically theological arguments regarding animals and establishes some theological principles. The second part focuses on specific issues such as animal experimentation, hunting for sport, killing for food and genetic engineering.

Creative Conservation is the result of the Sixth World Conference on Breeding Endangered Species, held in Jersey in 1992. The editors have developed the issues of the conference, whose theme was 'The roles of zoos in global conservation', and the resultant publication represents an update on successes and developments.

This book presents a full review of the biological, logistical and economic concerns that exist in all efforts to manage populations, and is a major contribution to the debate on interactive management of populations of animals under threat of extinction.

The above book has been written for those who are concerned about the use of animals in toxicity testing and are curious about the scientific status of alternatives. It includes chapters on 'Toxicology and toxicity testing' with subheadings 'Why test?' and 'What is an alternative?', 'Science *in vitro*' and 'Animal experimentation: ethics and the law'.

It has chronologies on, for example, tissue culture, United States animal welfare, Great Britain animal welfare, methodologies of vaccine development and has a comprehensive Bibliography and Index.

This handbook provides information for those working with animals under the *Animals* (Scientific Procedures) Act 1986. It gives an outline of legislation, offers advice on making a licence application, and is designed to act as an accompaniment to the Home Office training modules 1-4.

The biology, husbandry and biological data of large and small laboratory animals are covered. Emphasis is placed on best practice, with a view to enhancing welfare by improving techniques. The publication will assist the new licensee, whether in training or established.
