Rural poverty and impoverishment in Western Kenya

The study presents an in-depth, comparative inquiry into the scope and nature of the processes of socio-economic change that a number of areas in Western Kenya have been forced to contend with, from the time of their incorporation into the world economy up to the present. The study narrates the compelling stories of three peasant communities, of greatly varying population density, in terms of their different attempts at and mixed successes in mitigating the impoverishing impact of the usurious claims by the (post-) colonial economy. Income distribution and economic development: An analytical survey
by *J. Lecaillon, F. Paukert, C. Morrisson and D. Germidis*

The controversial question of income distribution in economic growth has received much attention since the Second World War. A general trend in the relation between income inequality and economic development was identified in 1955 by Simon Kuznets who saw inequality as first increasing and then decreasing in the course of economic development. This book sums up results of research carried out over the past 10 years. On the basis of a more rigorous statistical method (that confirms the general validity of Kuznets' thesis), it traces the effect on employment and incomes of the dualistic structure of economy in developing countries and the effective scope for the use of fiscal policy, government expenditure and other measures in reducing inequality as development proceeds.
