# U.S. Congress Encyclopedia Is Under Way

The Encyclopedia of the United States Congress, a four-volume scholarly reference work on Congress's history, members, structure, and policy making, is now in preparation. Publication is planned for late 1993 by Simon and Schuster's Academic Reference Division.

The Encyclopedia's coeditors are Donald C. Bacon, veteran Washing ton journalist and coauthor (with D. B. Hardeman) of *Rayburn: A Biography* (1987); Roger H. Davidson, professor of government and politics at the University of Maryland and coauthor (with Walter J. Oleszek) of *Congress and Its Members* (3rd ed., 1990); and Morton Keller, Spector Professor of History at Brandeis University and author of *Parties, Congress, and Public Policies* (1985).

Planned as the definitive reference work of its kind, the encyclopedia will contain approximately 1,500 signed original articles. Leading academics, journalists, elected officials, and congressional staff members will soon be invited to contribute articles on all aspects of the nation's legislature. The articles, varying in length from 250 to 7,500 words, will cover a variety of topics, ranging from Capitol art and architecture to the concept of representation and the role of the press. The encyclopedia will include interpretive biographies of famous and lesser-known congressional leaders, essays on legislative history, and thematic policy articles on such topics as foreign affairs, agriculture, labor, and civil rights.

The encyclopedia project, underwritten by the U.S. Commission on the Bicentennial of the Constitution, owes its origins to a group of political scientists, historians, and journalists convened several years ago by the D. B. Hardeman Bequest and the LBJ Foundation. Scholars and journalists alike concluded that a comprehensive reference work on the

U.S. Congress was needed to provide information and stimulate research. Subsequently the idea gained the endorsement of the Bicentennial Commissions of the Senate and House of Representatives. Administrative support is being provided by the University of Texas and the LBJ Library and Foundation.

# New Group Forms on Public Opinion and Foreign Policy

The idea for a group on "Public Opinion and Foreign Policy" was first proposed at a Roundtable on "Measuring Foreign Policy Attitudes" at the APSA Convention in San Francisco. This particular group was especially concerned with the need to call attention to recent evidence that public opinion was more sophisticated and stable than generally believed. The idea was that more political scientists should be made aware of this evidence, and a group should be formed to take advantage of new data and other opportunities for research in this

area. Because attitudes toward public opinion and foreign policy are so fundamental in shaping attitudes toward the whole range of domestic institutions that play a role in foreign policy, there was some feeling that the proposed group should include all those interested in domestic sources and foreign policy.

The individuals forming this new group are particularly interested in bringing together students of American and comparative politics who have a significant interest in defense and foreign policy and students of international relations who have a special interest in elite and public attitudes toward international issues. The group has been allocated one panel at the APSA meeting in Washington, D.C. next year. We hope that through co-sponsorship with existing groups we can actually offer two panels at the upcoming meeting. One of these panels would probably feature private political pollsters who have surveyed public attitudes on foreign policy issues. The other panel would be more theoretical and focus on the general topic of democracy and foreign policy. Individuals with ideas for one or both panels are encouraged to write to the address below.

In addition to ongoing discussions, the list editors would like to post announcements of job openings and upcoming conferences.

### Seminar Planned on the Myth and Reality of American Decline

The Massachusetts Institute of Technology (MIT) will offer a fiveday seminar, June 24-28, 1991, on whether and how the American political economy is "in decline." It will address the political implications both of the debate about "decline" and of proposals for addressing structural problems in the performance of the political economy. The coordinator of the seminar is Richard Valelly of the MIT Political Science Department.

The 1990 seminar had participants from Japan, Abu Dhabi, Mexico, Canada, and the United States; the group included political scientists, historians, sociologists, economists, and journalists. Speakers included MIT faculty in political science and management, a Georgetown University specialist in Japanese political economy, and the editor of an American quarterly of politics and opinion. They covered such topics as American foreign economic policy, US-Japanese economic rivalry, and successful and failed cases of industrial adjustment.

The 1991 seminar will cover similar topics and have a similar staff. Further, it will treat whether and how strengthened democratic processes are a condition of successful adjustment to a changed world political economy.

The MIT Summer Session is a mid-career educational service that has operated for over a century, mostly in engineering and management, but with a recent development of offerings in the humanities and the social sciences.
