Katelyn Barney is a Senior Lecturer in the Aboriginal and Torres Strait Islander Studies Unit at the University of Queensland. She is also an Australian Learning and Teaching Fellow. Her research focuses on facilitating pathways into higher degrees by research performers, and teaching and learning approaches in Indigenous Australian Studies. She is the managing editor of the *Australian Journal of Indigenous Education*.

Patrick Buckridge is Adjunct Professor of Literary Studies at Griffith University. He has published on the history of reading, literary biography, and Australian literature and journalism, especially of the interwar period. With Belinda McKay, he co-edited *By the Book: A Literary History of Queensland* (University of Queensland Press, 2007).

Melinda J. Cooper is a doctoral candidate and tutor in Australian literature at the University of Sydney. Her research explores Australian modernism in the novels of Eleanor Dark.

Anastasia Dukova is an Adjunct Research Fellow in the Griffith Centre for Social and Cultural Research at Griffith University. She is a historian specialising in the history of urban policing with a primary focus on Ireland, Australia and North America. Her monograph, *A History of the Dublin Metropolitan Police and Its Colonial Legacy*, was published by Palgrave Macmillan in 2016. Her new book, *Policing Colonial Brisbane*, will be published by the University of Queensland Press in 2018.

Kay Ferres is Professor Emerita in Literary Studies and Cultural History at Griffith University. Her current project, 'The Life of Houses', focuses on Australian writers and their relationships with place.

Mark Finnane FAHA FASSA is ARC Laureate Fellow and Professor of History at Griffith University. Currently he directs the Prosecution Project, hosted at the Griffith Criminology Institute.

Jane Frank is a Lecturer in the School of Humanities, Languages and Social Science at Griffith University with research interests in cultural studies, cultural sociology, and book and print culture. Her first book, *Regenerating Regional Culture: A Study of the International Book Town Movement*, will be published by Palgrave Macmillan in November 2017.

Nina Gartrell is a Doctor of Creative Arts candidate at the University of the Sunshine Coast. In 2012–13, she travelled overland (without flying!) from England

to Australia. Hers was an experiment in ecological ‘permatravel’ (permaculture travel). Her doctoral thesis, ‘Seeds: A Permaculture Travel Memoir’, is inspired by her permatravels and conveys her dual love for literature and gardening, nature and culture, roaming and homing. It is her attempt to reconcile the two impulses that have shaped her adult life: biophilia and wanderlust.

Tony Hassall is Professor Emeritus of English Literature at James Cook University and was Honorary Professor at the University of Queensland. He has published extensively on eighteenth-century English literature and Australian literature. His books include *Strange Country: A Study of Randolph Stow* (1986), and *Dancing on Hot Macadam: Peter Carey’s Fiction* (1994). He commissioned and edited the 30 volumes on Australian writers in the University of Queensland Press’s Studies in Australian Literature series.

Laurie Hergenhan is Professor Emeritus of Literature, University of Queensland. He is the founding editor of *Australian Literary Studies*.

Deborah Jordan is a historian, Senior Research Fellow (adjunct) at the National Centre of Australian Studies at Monash University, and long-term Palmer Scholar. She has published widely in Australian cultural history, on the environmental imagination and women’s history. Her report, *Climate Change Narratives in Australian Fiction*, came out in 2014; *Loving Words: Love Letters Between Vance and Nettie Palmer 1909–1914* is to be published by Brandl & Schlesinger.

Susan Lever has published widely on Australian literature, and is the general editor of the Cambria Press Australian Literature series. She writes regularly for *Inside Story* and is currently working on a study of Australian television writing. She is a past president and a life member of ASAL.

Belinda McKay was a founding co-editor of *Queensland Review*, and taught literary studies at Griffith University for twenty-five years. With Patrick Buckridge, she co-edited *By the Book: A Literary History of Queensland* (University of Queensland Press, 2007). She has a particular interest in the cultural history of the greater Brisbane area, and has previously written on Eleanor Dark’s residence on the Blackall Range.

Daniel May is a PhD candidate in the School of History, Australian National University. His research focuses on the politics of Indigenous burning in Australia and the United States from 1910 to 2016.

Roger Osborne is the 2016 University of Queensland Fryer Library Fellow. Roger is a scholarly editor and book historian. For Cambridge University Press he has edited Joseph Conrad’s *Under Western Eyes* (2013) and *Nostromo* (2018), and in 2017 Sydney University Press will publish his book (co-authored with David Carter), *Australian Authors in the American Marketplace 1840s–1940s*.

Susan Sheridan is Professor Emerita in Humanities at Flinders University and a member of the Australian Academy of the Humanities. She has published widely on women’s writing, feminist cultural studies and Australian cultural history. Her latest books are *The Fiction of Thea Astley* (Cambria Press, 2016) and *Nine Lives:*

SUBMISSION INSTRUCTIONS

Queensland Review publishes articles of approximately 5000-6000 words. Please email submissions to *Queensland Review* to the Lead Editor, Professor Kay Ferres, at: k.ferres@griffith.edu.au

1. At least two separate files must be submitted. If there are figures, three or more separate files must be submitted.
 - i A Title Page document. The name of this file must be constructed as follows: [first 20 characters of the title]_[ddmmyear]_QR_Title.doc
 - ii An Article document. The name of this file must be constructed as follows: [first 20 characters of the title]_[ddmmyear]_QR_Article.doc
 - iii Any Figure documents should be supplied with the name of the file constructed as follows: [first 20 characters of the title]_[ddmmyear]_QR_Figure# (with # being the number of the figure)
2. The Title Page and Article documents should be saved as Microsoft Word documents, in Times New Roman 12 pt font, double-spaced with margins of at least 25 mm on both sides and in A4 page size.
3. The Title Page document should contain the full title of the article as well as the full names and affiliations of all authors followed by full postal and email addresses for the corresponding author. A word count and suggested running head of no more than 50 characters including spaces should also be provided.
4. The Article document should include the complete article without any identifiable author details but including the title and an abstract not exceeding 200 words that provides a brief overview of the aims, method and major findings, without any citations. The abstract will not be published, but may be used for publicity purposes.
5. Tables should be created in Word and included at the end of the article after the references, with their approximate positions in the text indicated by the words, 'Insert Table X here'. Horizontal and vertical lines should be used sparingly.
6. Figures, graphs, illustrations and photographs (but not tables) should be prepared to the correct size and each one supplied as individual files, separate to the article. To ensure optimal quality, please follow the guidelines provided in the full instructions available at [cambridge.org/qre](https://journals.cambridge.org/qre)

A list of figure captions should follow the tables in the article document. Captions must include sources

and permissions for copyright material. It is the responsibility of the corresponding author to obtain written permission to reproduce any photographs or other copyright material.

REVIEW

All manuscripts are sent for blind peer-review to members of the editorial board and guest reviewers. The review process generally requires three months. The receipt of submitted manuscripts will be acknowledged by the editor, from whom a decision and reviewers' comments will be received when the peer-review has been completed. Papers submitted to the journal must not previously have been published, and must not be submitted for publication to any other journal while under consideration for *Queensland Review*.

STYLE AND REFERENCING

For details of the *Queensland Review* style, please see the style and referencing guide available at journals.cambridge.org/qre

1. Authors should follow Australian spelling and punctuation conventions throughout their articles (except in quotations from other sources, where the spelling convention of the original should be retained). Use the Oxford English Dictionary.
2. Use single inverted commas, except for quotations within quotations (which have double inverted commas). Punctuation should follow closing inverted commas except for grammatically complete sentences beginning with a capital.
3. Since *Queensland Review* is a multi-disciplinary journal, we accept referencing using either the short-title (endnote) system or the author-date (Harvard) system, depending on the disciplinary base on the author. Each individual paper must conform to one or other of these systems.
4. Use endnotes, not footnotes.
5. Include a bibliography only if the author-date (Harvard) system of referencing is used.
6. Generally notes should be kept brief. Source references should be given with as little additional matter as possible.
7. Quotations should be kept to a minimum and lengthy quotations should be avoided. As a general rule, quotations of more than about 60 words should be set off from the main text (indented with extra space above and below). Those of fewer than 60 words should run on in the text inside inverted commas.
