Intensive Bioethics Course XXI

The twenty-first annual Intensive Bioethics Course, sponsored by the Kennedy Institute of Ethics at Georgetown University, will be held from Sunday evening, June 4.

through Saturday noon, June 10, 1995. The course is an in-depth study of ethical theory and the application of ethical principles to selected problems in health care and biomedical research. Limited to 200 participants, it is directed primarily toward physicians, nurses, and policymakers in the health care field.

Lecture topics have traditionally included theories of normative ethics; the principles of beneficence and non-maleficence, autonomy, and justice; virtue-based ethics; the ethic of care; health care allocation; informed consent; bioethics and the law; death and dying; and human gene therapy.

Axelrod Bibliography

An annotated bibliography of works that make use of Robert Axelrod's *The Evolution of Cooperation* (Basic Books, 1984) or earlier work included in that book is now available. The bibliography includes over 200 items with abstracts, and covers the period 1988-94. It supplements a previous bibliography that covered the period until 1988.

Recent research areas that have been particularly active include allowing more than two players, altering the standard payoffs, introducing noise, and providing population structure. Population dynamics (including evolutionarily stable strategies) and limited sets of allowable rules have also been major research topics. In addition, there have been a wide variety of new empirical applications from anthropology, biology, economics, law, politics, psychology, and sociology.

Meeting of European Sociobiological Society

The eighteenth annual meeting of the European Sociobiological Society will be held August 3-6, 1995, in Christ's College, Cambridge, England. This meeting is intended to provide opportunities to see how coherently sociobiology—as currently pursued—continues and develops the original Darwinian insights, and to assess the achievements—and failures—of the sociobiological approach set against the larger context of evolutionary biology.

The topic of "The Darwinian Heritage and Sociobiology" is especially appropriate because this meeting will take place in Darwin's own college at Cambridge. If enough interest is shown, an excursion to Darwin's home, Down House, will be organized. Accommodations will be provided in one of the modern blocks of the College. Reservations must be made by May 31, 1995, and paid for in advance (single rooms £24 p.n.; full board £65).

Fulbright Scholar Awards

Fulbright scholar awards are now available to offer U.S. faculty, professionals, teachers, and students the opportunity to conduct research, teach, or study abroad and to make a contribution to the growth of mutual understanding among countries and individuals. Over 31,000 U.S. scholars have traveled the globe as Fulbright lecturers and researchers since the beginning of the program. The 1996-97 program year marks the program's 50th anniversary.

Awards range from two months to a full academic year, and assignments are flexible. Openings exist in almost every area of the arts and humanities, social sciences, natural and applied sciences, and professional fields. Fulbright recipients include academic administrators, independent scholars, artists, and professionals from the private and public sectors.

Eligibility requirements are U.S. citizenship and a Ph.D. (or comparable professional qualifications). University or college teaching experience is expected for lecturing awards, and language skills are needed for some countries, although most lecturing assignments are in English. Funding is provided by the U.S. Information Agency and cooperating governments and host institutions abroad.

The deadline for lecturing and research grants for 1996-97 is August 1, 1995. Other deadlines for special programs include distinguished Fulbright Chairs in Western Europe (May 1) and Fulbright seminars and academic administrator awards (November 1).
