THE CASE AGAINST DIRECT ELECTION OF THE PRESIDENT

A Defense of the Electoral College

Judith Best

One firm vote of confidence is cast here for the present system of electing the President. Professor Best refutes the arguments in favor of direct election and presents a convincing case for the electoral system, asserting that its faults, great as they may be, are far outweighed by its virtues.

Making use of hard data on electoral and popular votes, she shows that proponents of direct election have not borne the burden of proof. Point by point, she explains persuasively her reasons for rejecting the various criticisms of the electoral college. She identifies the merits of the existing system, arguing that they have been confirmed by the solid test of experience. Statistically, historically, and politically, the system is not neutral, she concedes, and she shows that it was designed to favor coalitions that are highly advantageous in a large, heterogeneous republic.

Since the best way to assess an institution is to determine how successfully it functions, Professor Best describes the electoral system within the context of American government and politics. Sensible and informed, her book makes a valuable contribution to the continuing debate on the critically important subject of how the nation selects a President.

Soviet-American Conflict over Eastern Europe

A critical issue in the origins of the Cold War—the development of Soviet-American conflict over Eastern Europe from 1941–1945—is the subject of this book. Disagreeing with those writers who argue that conflict arose from the determination of the United States to obtain economic markets in Europe or from imprecise assessments of Soviet security interests, the author describes how the United States made an initial commitment to the Atlantic Charter principles in 1941, then continued to promote the creation of representative governments in Eastern Europe without clearly identifying American interests or foreseeing the consequences of these actions.

A TACIT ALLIANCE

France and Israel from Suez to the Six-Day War

Almost immediately after Israel declared its independence in 1948, it began to benefit from a unique series of scientific and military exchanges with France. These exchanges, arranged for the most part outside normal diplomatic channels, were in conflict with the official pro-Arab position of the French government, and also ran counter to Israel's leanings toward the United States, Britain, and the Commonwealth countries. They thus indicated the beginnings of a "tacit alliance"—a relationship of mutual cooperation and support based on no official government contract.
