The export-oriented industrial development strategies currently pursued by many developing nations find concentrated expression in the Free Trade Zones which have proliferated during the last decade in Asia and are presently spreading to other regions.

The present study, the first systematic exploration of the FTZs, analyzes the origins of the strategy in the 1960s in the intersecting goals of government planners and multinational corporations, the theoretical implications of the FTZ strategy, and provides concrete case studies of their impact on five ASEAN nations, South Korea and Taiwan.

The study, incorporating the research of Japanese, Southeast Asian and Western researchers, locates the FTZs within the current international debate concerning the role of multinational capital in contributing to development or dependence.
