Volume 4. Grappling for Control

Since the publication of the first three volumes of this monumental work, the name of Dr. Radzinowicz as a legal historian has been coupled with Holdsworth, Pollock and Maitland. But this work does more than just trace the history of the criminal law. It is at the same time a fascinating study of the social pressures which have, over the years, determined and compelled the evolution of penal legislation.

The earlier volumes studied the initial movement for the reform of the criminal law, with particular reference to capital punishment, analysed the disputes which surrounded the proposals for the creation of a preventive police force, and showed how the reform of the police became an issue more disputed than the revision of the criminal law itself.

The present volume follows through to their conclusion these two protracted campaigns; the one for the reform of the capital laws, the other for the establishment of regular police.

At the end of the eighteenth century the capital code overshadowed the whole of the criminal law. By 1861, for all practical purposes, the only offence to carry the death penalty was murder. At the end of the eighteenth century the enforcement of the law still depended upon the unpaid parish constable and the offer of rewards, and the quelling of riots by the intervention of the armed forces. By 1861 the country was covered by a network of professional police charged with the prevention of crime, the detection of offenders and the maintenance of order. Systematic enforcement of the law had replaced suspended terror as the accepted basis of control.
