*Government and Opposition* is one of the world's leading global comparative politics journals. This means that we publish papers dealing with any part of the world, and on any theme, to do with comparative politics, liberally defined. We accept papers that cover a single case, so long as they are positioned within the comparative politics literature and seek to advance comparative political analysis. We also publish substantial review articles, many of which are commissioned, and some of which are the result of proposals made to our review editor. We are tied to no substantive position, nor to any methodological orthodoxy beyond the fundamental principle of intellectual rigour. To ensure rigour we practise anonymous refereeing. We publish four issues a year.

## Submissions

*Government and Opposition* has a tradition of publishing in a style accessible to any interested reader, and we encourage authors to write in a style as clear and simple as the subject matter allows.

Articles should include a word count: in general the length of articles, including references and notes, should be limited to 10,000 words. Articles should be made anonymous, with all self-identifying mentions removed (including in the file name) to enable the anonymous-reviewing process. Articles should be accompanied by an abstract of around 150 words and five keywords. We ask that authors deposit their data in a publicly available repository except in valid situations for ethical reasons. Datasets will be hosted on the publisher's platform alongside the article.

All articles must be submitted in accordance with the journal's style guide (available from journals.cambridge.org/gov). The journal cannot consider any article that is also under consideration by another journal.
