All communications, including manuscripts for publication, should be sent to The Editor, *British Journal of Psychiatry*, 17 Belgrave Square, London SW1X 8PG.

Full instructions to authors are given at the beginning of the January issue.

Two copies of the manuscript should be submitted and the author should retain a copy. Articles must be typed on one side of the paper only, double spaced with wide margins.

Contributions are accepted for publication on the condition that their substance has not been published or submitted for publication elsewhere. The BJP does not hold itself responsible for statements made by contributors. Unless so stated, material in the BJP does not necessarily reflect the views of the Editor or the Royal College of Psychiatrists.

Published articles become the property of the BJP and can be published elsewhere, in full or in part, only with the Editor's written permission.

The names of the authors should appear on the title-page, and their names, degrees, affiliations and full addresses at the end of the paper. A summary should be given at the beginning of the article. References should be listed alphabetically at the end of the paper, the titles of journals being given in full. Reference lists not in BJP style will be returned to the author for correction. The text reference should be in the form '(Smith, 1971)' or 'Smith (1971) showed that . . .'. Brief reports should cite a maximum of 10 references. 'Personal communications' need written authorisation. No other citation of unpublished work is permissible.
