In recent years, his research addressed the interregional diffusion of (and resistance to) rules and institutions promoting transnational corporations' investments among Europe, North America, and South America. Thanks to the Konrad Adenauer Research Award, his latest work was integrated into the "Transformative Power of Europe" research project at the Free University of Berlin.

CARMEN DIANA DEERE is Distinguished Professor Emerita of Latin American studies and food and resource economics at the University of Florida. She has been a visiting scholar and visiting professor at FLACSO-Ecuador, where she directed the UF-FLACSO "Gender, Poverty, and Assets" study. She is coauthor, with Magdalena León, of *Empowering Women: Land and Property Rights in Latin America* (2001), which was awarded LASA's Bryce Wood Book Award. She is an associate editor of *Feminist Economics* and coedited two of its special issues, "Women and the Distribution of Wealth" (2006) and "Gender and International Migration" (2012).

LUIS GABRIEL GALÁN-GUERRERO es historiador y magister en historia de la Universidad de los Andes. Actualmente es investigador del Centro de Estudios en Historia (CEHIS) de la Universidad Externado de Colombia y ha trabajado como asistente de investigación del Centro de Estudios Latinoamericanos, St. Antony's College, de la Universidad de Oxford. CHISU TERESA KO is an assistant professor of Spanish and Latin American studies program coordinator at Ursinus College. She specializes in Latin American literary and cultural studies, with a particular interest on nineteenth-century and contemporary racial discourses in Argentina. Her most recent work focuses on Argentine multiculturalism and Asian Argentines. She is currently working on a book manuscript that examines the key role of cultural discourses in producing and transforming racial meanings throughout Argentine history. She holds a doctoral degree from Columbia University.
